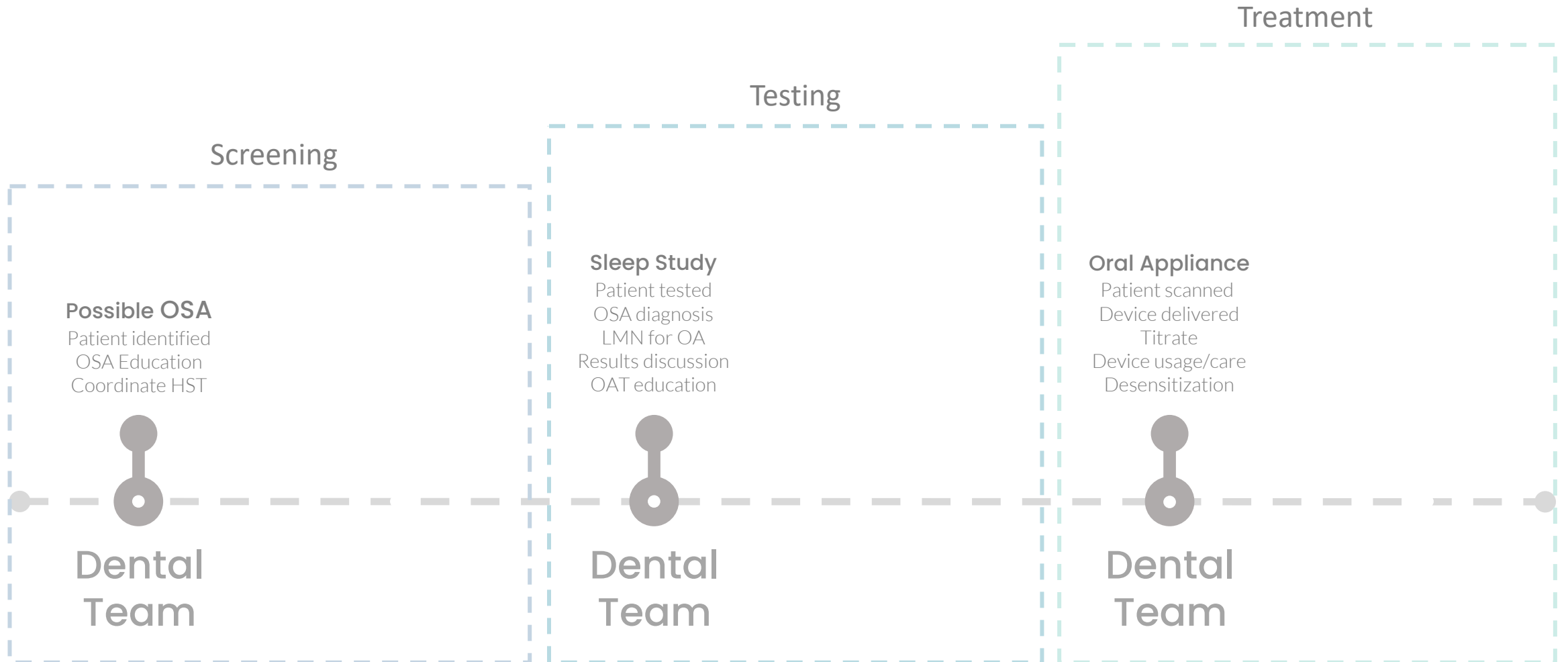

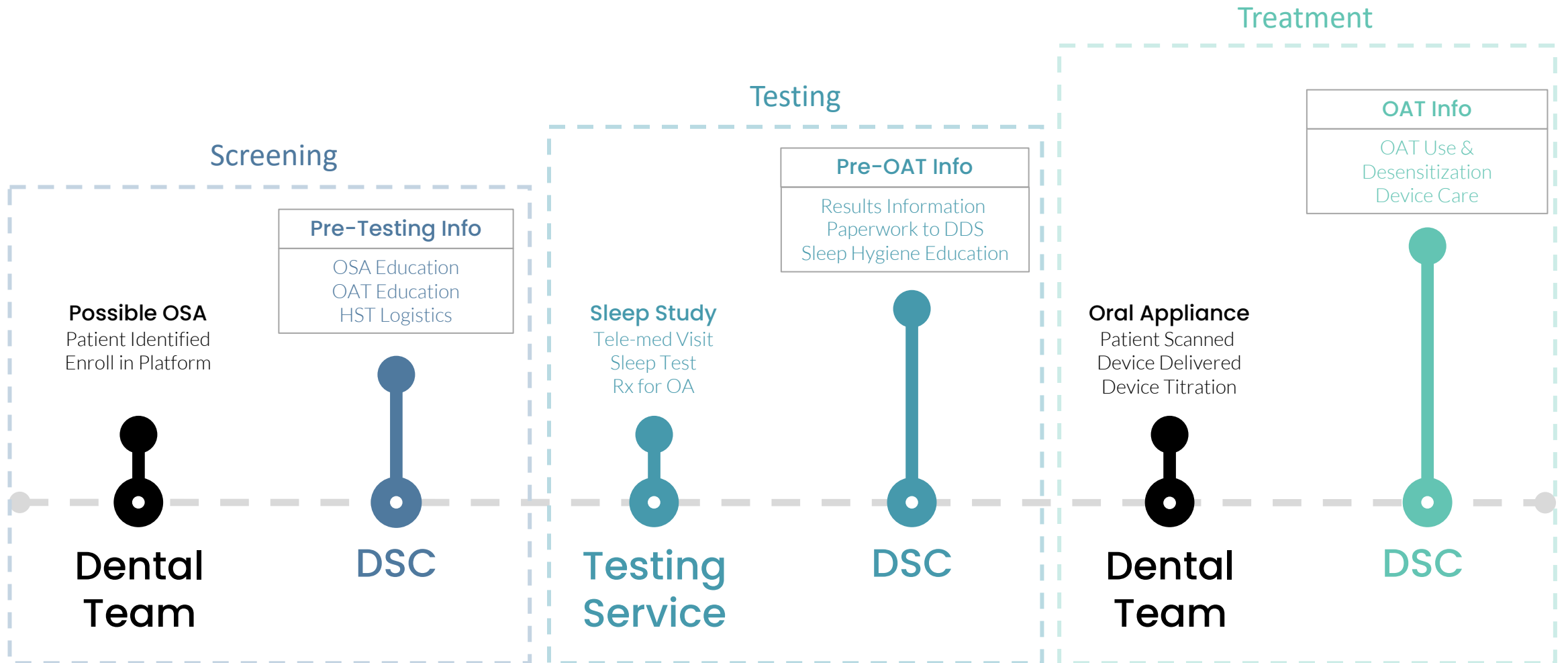
Current State

Typical patient journey and associated workflow in the dental sleep practice

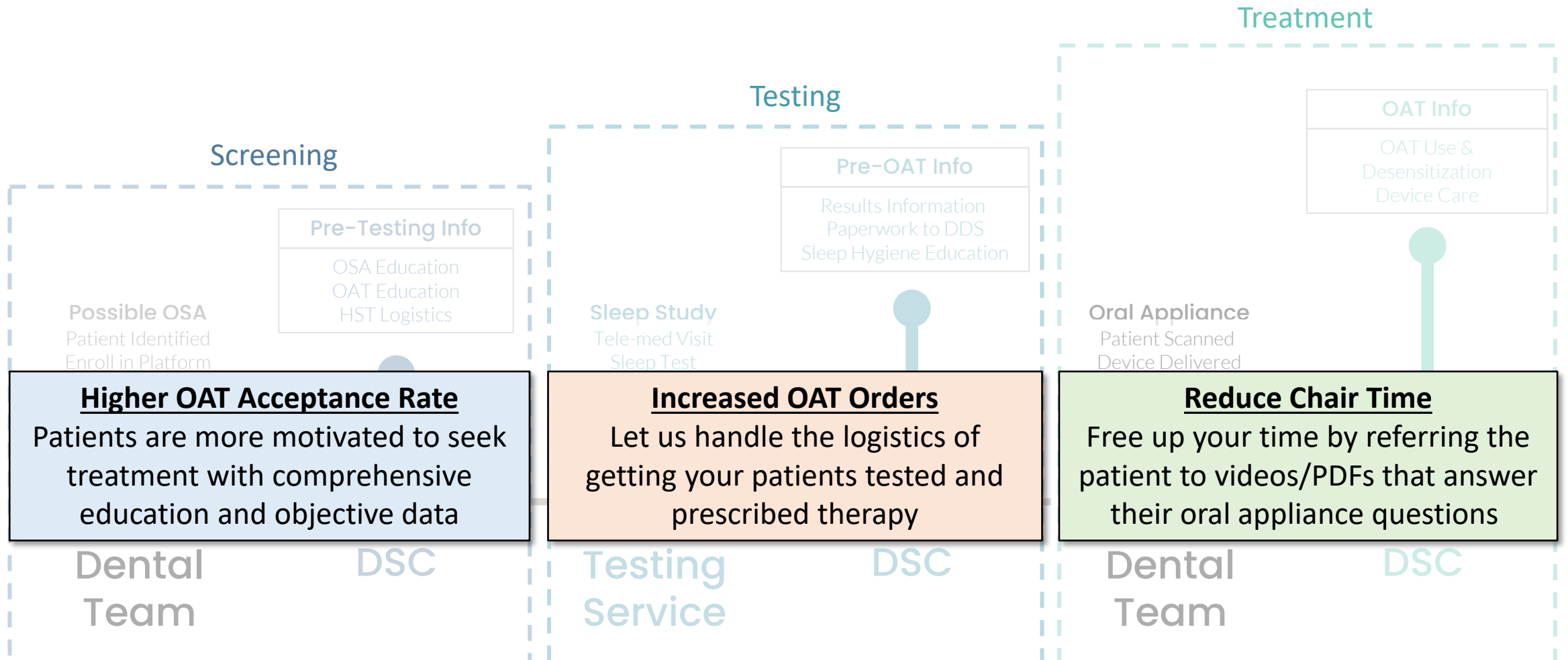

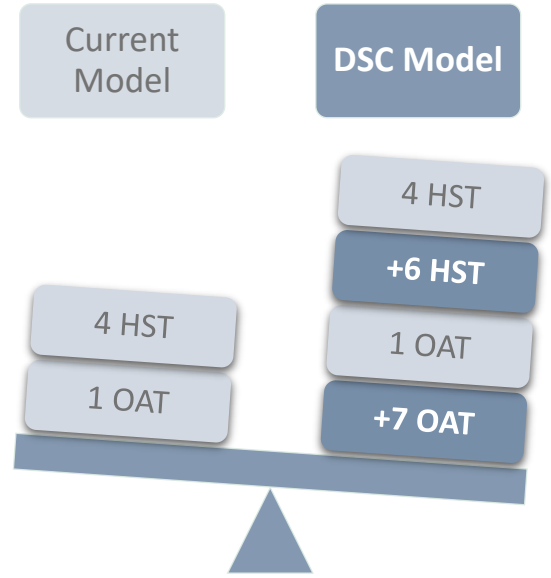
Monthly Profitability for Dental Practice*

Coordinating the testing process increases the number of patients that follow through with sleep testing

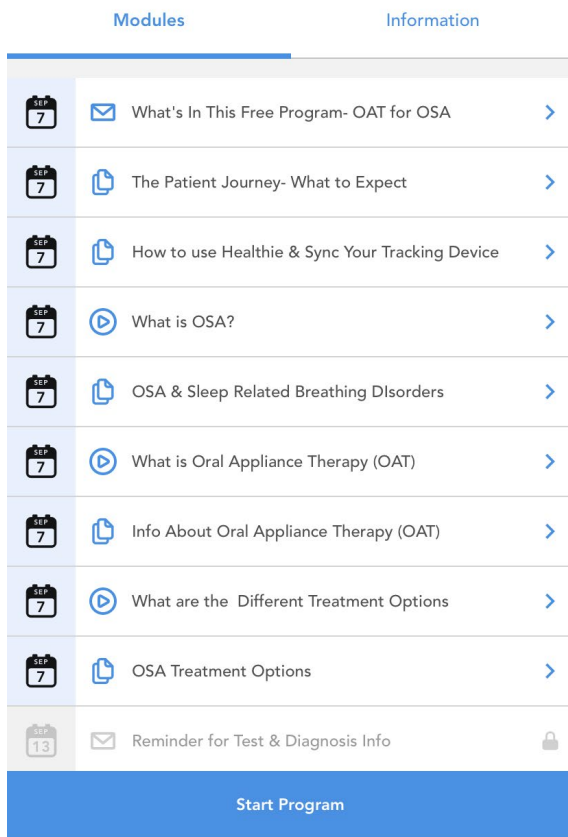
Current = 4 out of 16	DSC = 10 out of 16

Screening

- Electronic OSA screeners to automate the screening process (potential integration with Dentrax)
- Can be emailed, texted, or captured on a tablet in the waiting room

Paperwork

- Provide an easy pathway to gather documents from external referral sources
- Capture patient medical info, signatures, and insurance info directly in the platform

Insurance

- One-click eligibility verification
- Outsourced authorization submission and tracking
- Auto-generated patient financial responsibility

Tracking

- Know where the patient is through every step of the process
- Set automated notifications to inform you when there are delays

Claims

- Automate the claim submission process after device delivery (significant cost savings compared to other DSM softwares)
