ABOUT THE ORGANIZATION

Vikas Sahyog Kendra (VSK) is a non-government organization registered in Jharkhand. The organization evolved from a massive campaign on drought proofing campaign (*Sukha Mukti Abhiyan*) to conserve water resource in Palamau district, in the early nineties. The Campaign was anchored by *Pani Chetna Manch*, a forum comprised of civil society organizations, dynamic social activists, farmers, researchers, engineers, women and youths.

Majority of the founder members of VSK were associated with the *Sukha Mukti Abhiyaan* where they contributed in the creation of 140 water-harvesting structures in severely drought affected 125 villages of Palamau district.

Vikas Sahyog Kendra is a non-government organization, established by a group of young and dynamic activists of technical and social backgrounds. The organization is actively engaged in organizing marginalized farmers & tribal communities at village to state level with adequate representation of women and youths in realizing their rights and entitlements in accessing land & livelihood resources and scaling up their

This had demonstrated local water management as an effective alternative to the building of large dams. *Pani Chetna Manch* transformed into Vikas Sahyog Kendra as a registered organization in 2000. Since its formal registration, VSK has been working in three districts – Palamau (Daltonganj/Medininagar), Latehar and Garhwa in Jharkhand.

VSK works with a mix of rights based approach with development initiatives to secure access to natural resources, public investments and welfare benefits that contribute to livelihoods of *Adivasis* and *Dalits*. The approach comprises of organizing and capacitating the primary stakeholders into common interest groups, establishing their specific advocacy forums at multiple levels to collectively access resources and provide technical support.

VSK has worked on several programs at state, district, block and panchayat level emphasizing the issues of lands and livelihoods rights of poor and marginalized communities. It has been addressing the problems and issues expressed by the deprived people in rural areas with special focus on rights and development of *Adivasi*, *Dalit* and Women.

VSK has alliances with various national and state level networks like Revitalizing Rain-fed Agriculture Network (RRAN), MGNREGA Watch, MGNREGA Consortium, Right to Food Campaign, Jungle BachaoAndolan, Jharkhand Van Adhikar Manch, Right to Life with Dignity, Gram Swaraj Abhiyan and V B Net Foundation.

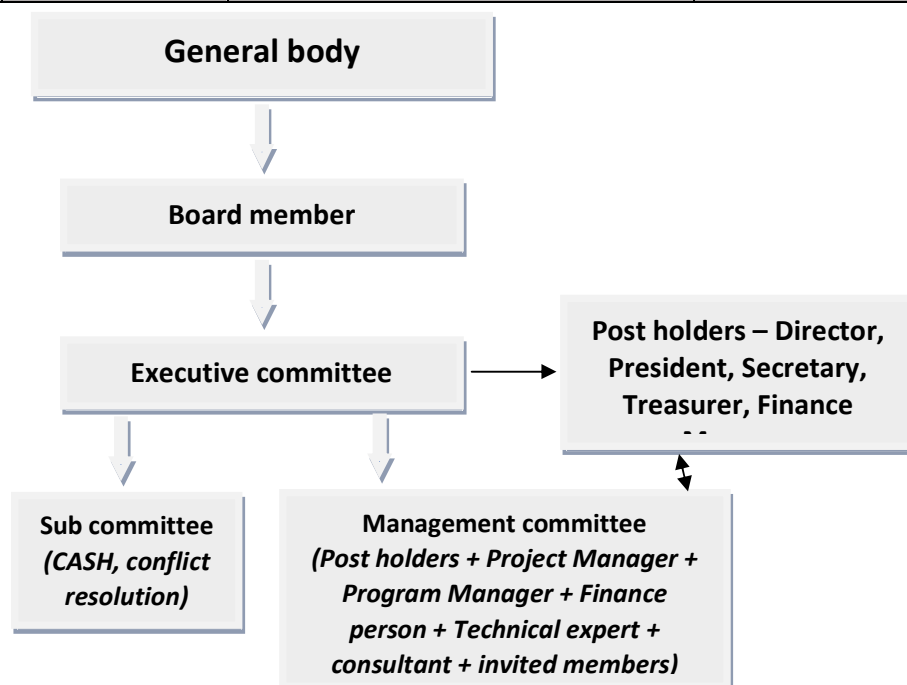

Executive summary of the project

This project will be conducted for a period of three years (June 2022 to June 2025) across 46 villages under 8 gram panchayats in Nawa Bazar block in Palamu district of Jharkhand.

The rural households of the selected area are facing a large number of socio-economic problems including poverty, drought, ground water depletion, lack of clean energy sources, crop failure, food & nutritional insecurity, irregular PDS system, poor quality of government service delivery through social security schemes, unemployment, indebtedness and painful migration. Looking at the worst situations, we have implemented several activities effectively to reduce the problems of the targeted households.

The overarching objectives of the project is to strengthen the local self governance structure by strengthening Gram Sabha, ensuring rights & entitlements through social security schemes, wage based entitlements through MGNREGA, community & individual claim filing under FRA act, 2006, intervention in PVTG communities in three verticals of health & nutrition, conserving the traditional culture & systems, livelihood generation.

Objective wise result & outcome

In the current reporting year, Vikas Sahyog Kendra team has observed quiet satisfactory results in terms of outcomes based on project activities undertaken.

Through out the year our team has worked in a dedicated fashion to achieve results based upon the agreed indicators.

Staff recruitment process was started from June to July where Block Coordinators, MIS officer, Cluster facilitator & Community Resource Persons were selected by written exam followed by interview. Team orientation program was organized at GSA office, Kanda on 6 July 2022 where Jawahar Mehta detailed about the project and discussed on the approach and methodologies of project implementation in the project area.

Since it was the first year of the project, in the initial few months we mostly focused on the learning aspects to build a solid foundation among the staffs. Our primary focus during first few months was to build a thorough understanding about the local village dynamics, socio cultural trends, political scenario, identifying key local leaders etc. We also focused on building local stakeholder relationship, village level surveys were conducted, trainings were provided to staffs on various topics ranging from constitutional provisions related to the project, provisions of Panchayati Raj Act, Forest Rights Act, PRA & social mapping, social security schemes, NFSA etc.

Grassroots mobilization through awareness generation, demand generation for rights and entitlements, community mobilization has been conducted. Advocacy efforts have been put at block & district level to regularize PDS distribution system, pending forest rights claims have been followed up. Regular Gram Sabha meetings in the presence of local leaders have been conducted across villages. Also we have conducted regular Tola sabha meetings, meetings with labour groups, SHG groups. Phase wise trainings have been conducted for traditional leaders including Gram Pradhan, PRI members, Mukhiya, FRC committee members in ranging topics related to Panchayati Raj system, Roles & Responsibilities of Gram Sabha, provisions of FRA Act etc.

As a result in the later months of the year we finally started to see impacts across verticals as there was a marked increase in the community participation (Including women participation) in Gram Sabhas, as well as Gram Sabha were more regularized in 21 villages. PDS related issues were addressed & resolved by Gram Sabha in two villages.

Objective 1- *Strengthening local self-governance and traditional system by empowering Gram Sabha*

Activity 1.1 -

Nawabazar block comes under the non-scheduled area where there is no provision of Gram Pradhan & Up-Pradhan system, but VSK initiated to select Gram Pradhan & Up-Pradhan through the Gram Sabha in each of the 46

Training Gram Pradhan/ Village Head/ Traditional Leader	villages. In the reporting year, a total of two training programs have been conducted by VSK where 70 Gram Pradhan Upa Pradhan & other traditional leaders took part where they were equipped with the knowledge about historical background of the panchayati raj, duties& rights in Gram Sabha, communication and writing gram sabha proceedings and GPDP. A video documentary was also watched by the trainees of Gram Sabha. The effective IEC materials were used during the training along with showing video documentary through projector.
Activity 1.2 - Training PRI Member (Mukhya and ward members)	In the first six months we have enlisted 8 Mukhya and 104 Ward Members from all the 8 panchayats of Nawabazar block. Our team members use to meet regularly to all the PRI members. A four days training program was organized by VSK from 21st March to 24th March particularly for PRI members including Ward members where total of 74 PRI members were provided training on various topics pertaining to local self governance structure like Panchayati Raj Act, Roles & Responsibilities of Gram Sabha, 7 standing committees of Panchayat, power structure of government - Executive, Administrative, Judiciary etc.
Activity 1.3 - Providing material for setting of Gram Sabha Secretariat	Gram Sabha secretariat has been set up in 7 villages in this reporting year. This is as per the provisions in the project we have provided registers and information materials in Hindi such as The Jharkhand Panchayat Raj Act 2001, MGNREGA, FRA, Social Justice, Gender Equality, Social Welfare, Natural Resource Management, Govt. Schemes and Employment & Livelihoods etc.
Objective 2- <i>Strengthening tribal culture & traditions and supporting PVTG families in emergency needs</i>	
Activity 2.1 - Traditional knowledge sharing/ Experience sharing meeting	We have identified traditional leaders in all the 8 PVTG villages to conduct traditional cultures & knowledge sharing meetings with children group. Total 23 such meetings with children have been organized so far where

	almost 500 children has been participated. The topics of discussion revolved around illness & its traditional ways of treatment, traditional ways to celebrate various festivals, traditions related to marriage, farming & agriculture etc.
Activity 2.2 - Support as fellow for mapping and documentation specially for PVTG villages	We have selected one fellow for this position. Also with the assistance of an intern a research study paper has been prepared on 8 PVTG villages outlining the various issue faced these communities in terms of lacking drinking water, social security schemes, entitlements through MGNREGA, scarce livelihood opportunities, irregularities in PDS distribution system & poor service delivery through local government.
Activity 2.3 - Additional nutrition supplement specially PVTG HH	In the second quarter of the project, we identified and enlisted malnourished mothers, children, and teenage females from the project region. In the third quarter, we also held a health check-up camp in three villages, where 162 people were identified as having different health conditions. After compilation & listing 130 selected PVTG families were provided with additional nutrition support.
Activity 2.4 - Emergency medical fund specially for PVTG HH	There are so many women, children and old age people who are in need of emergency support. We are categorizing those people who are in severe condition. In this reporting year two PVTG families were directly supported by us in emergency medical needs.
Objective 3- <i>To claim for Community Forest Right (CFR) and Individual Forest Rights (IFR)</i>	
Activity 3.1 - Staff training to train FRC Member on preparation of legal documents to claim for CFR & IFR	Two staff trainings on Forest Rights Act have been organized in this reporting year. The training was focused on the preparation of legal documents to claim for community forest right and individual forest right. One training program on FRA was also organised separately for FRC members.
Activity 3.2 - Formation of FRC committees	We have re-formed the Forest Right Committee in 24 villages of 7 panchayats of Nawabazar block. There are 15 members including 10 men and 5 women in each of the FRC. A total of 240 men and 120 women are

	associated with the 24 committees.
Activity 3.3 - Support for IFR claim	The process of IFR claim is yet to start as we are currently focusing on CFR claim only. The FRC committees have been identifying & listing the IFR beneficiary list in each village. A total of 363 families have been identified for IFR claim so far.
Activity 3.4 - Support for preparation of CFR claim	We have made a significant progress in CFR claim process this year. In 10 villages the FRC committee has officially informed the SLC about the initiation of the process of concept of rights on community forest resources, which will be given in writing by the Forest Rights Committee.
Activity 3.5 - Claim follow up with DLC & SDLC	This year, we have arranged four different meetings with SDLC/DLC in Palamu district on the issues of land patta/lease. Information regarding 300 IFR & 5 CFR pending claims have been collected & meetings have been scheduled with block & district officials for further processing.
Activity 3.6 - Exposure Visit to understand forest development plan and self governance	A five days long exposure visit was organized by VSK at Mendhalekhamodel village in Gadchirauli, Maharashtra from 24th to 29th May. Total 18 person including VSK staffs & 10 FRC members participated in the visit. The team was demonstrated with the working business model of using forest resources to create livelihood opportunities & creating value chain through forest resources.
Activity 3.7 - CFR management Plan in Chhattarpur where already CFR Patta has provided	The CFR management plan has been completed in two villages in Chhattarpur block.
Objective 4- To ensure ration, pension and employment through Social Security Schemes & MGNREGA	
Activity 4.1 - Cadre training for demand generation and	We have provided phase wise trainings to the village cadres. Two cadre training programs has been organized in this year on various topics like online submission of pension ration

application preparation for Social Security Scheme	card application, online checking of the application status etc. Right now we have 15 active cadres across 22 villages.
Activity 4.2 - Identification of vulnerable and deprived families to link welfare scheme and MGNREGA	The eligible families have been identified & listed in 23 villages. We have submitted the online application of ration & pension of 174 eligible families.

Overall Objective

The requirement for the large investments for the community development projects, primarily in disadvantaged communities is high. More often than not, such projects require investments much beyond the donor funding. In this scenario, leveraging Mahatma Gandhi NREGA fund works out to be a useful source for financing large community projects.

This project aims to enhance the technical capacities to implement the program at the block and gram panchayat levels and thereby increase the scale of MGNREGA works, reduce delays in wage payments to workers and improve the quality of assets constructed under the program.

Enhancing the quality of implementation of MGNREGA scheme

Regular MGNREGA site visits have been conducted, and technical suggestions based on necessity have been offered to GP officials to guarantee appropriate work flow at each MGNREGA site. Inputs have been offered ranging from proper site selection to resource utilisation, timely wage payment, increased work demands to boost the scope and effect of MGNREGA at the village level.

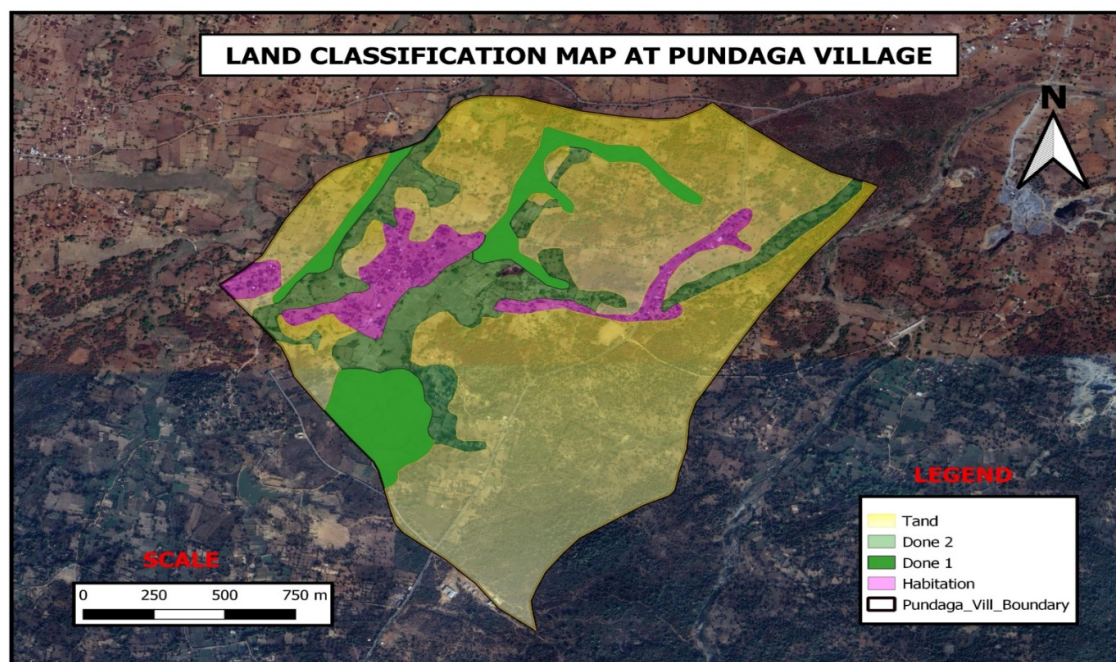

Developing GIS (Geographical Information System) based plan

Preparation of GIS based NRM (Natural Resource Management) plan is under process in two blocks. GIS-based plan will be used to identify specific MGNREGA projects based on the priorities and needs identified, considering the potential for sustainable asset creation, natural resource management, and livelihood enhancement. GIS based plan will also be used to identify suitable sites for MGNREGA projects, such as water conservation structures, rural roads, afforestation, and livestock management.



Horticulture

Around 106 acre of land has been selected for plantation under BHGY(Birsa Harit GramYojna),2023-24 & Didi Bari scheme. The sites have been selected by following BHGY guidelines.In Chattarpur block,37 acres of land has been sanctioned & pit digging for plantation has been started in 3 acres of land.

Total 67 eligible farmers have been identified for Didi Bari scheme including 33 from SC category & the rest from OBC category.

Awareness Generation&sensitization of GP functionaries at block level

Special focus has been put on mass awareness generation, particularly among the SC ST community to enhance their overall understanding regarding the rules & regulations of MGNREGA Act, their rights & how to take advantage of the scheme.

Targeted campaigns have been conducted in 20 panchayats in Chattarpur&Ramkanda block to raise awareness about the objectives,provisions & benefits of MGNREGA & also to Encourage active participation and address queries and concerns of the community members.

Continuous sensitization has been done for the GP functionaries, including elected representatives, Panchayat Secretaries, and other officials involved in MGNREGA implementation on various aspects of MGNREGA, including its objectives, provisions, rights and entitlements of beneficiaries, roles and responsibilities of GP functionaries, project planning and management, social audits, and grievance redressal mechanisms.

Training & Capacity building of staff

A 3 days training program has been organized by the Jharkhand state CFP team at DRDA Garhwa. The overall objective of the training was to enhance the technical knowledge & skill of block CFP team in Water shade, NRM Agro climatic statics of Jharkhand, QGIS expectations mapping, implementation structure MGNREGA, Watershed mapping through Bhuvan etc.

OTHER ACTIONS UNDERTAKEN

Protective Irrigation

The Palamu district lies in the rain shadow zone. Drought is a frequent occurrence in this section of Jharkhand, occurring around every three years. To address this predicament, the organisation has undertaken a number of initiatives in recent years. To conserve crops during a drought, the organisation built the Boda Band (3 villages), installed solar lifts (5 villages), and built agricultural ponds (300-100 communities). In



Millet's Promotion

We are currently experiencing three issues as a result of climate change: a rise in temperature, a decrease in rainfall, and malnutrition. The cultivation of coarse grains is particularly successful in addressing these issues. In this spirit, the organisation is promoting millets cultivation. In this year 50 farmers from Hutukdag and Hulsam Gram panchayat have been engaged in Madua cultivation across 10 acres of agricultural land.



Multilayring Farming

The organization has worked with 20 women farmers in Hutukdag village of Chhattarpur block for cultivation of multiple layering vegetables. This farming is completely organic. This is a very good model of 15 decimal for small farmers, which earns 50 to 60 thousand in a year. People get good nutrition from chemical free vegetable. Ginger, tomato, bitter gourd, bottle gourd, spinach, nanua, etc. are grown in multi-layering.



Climate Action

Climate change is a significant global concern that refers to long-term shifts in weather patterns and average temperatures on Earth. It is primarily caused by the increased concentration of greenhouse gases, such as carbon dioxide (CO₂), in the atmosphere. These gases trap heat and contribute to the warming of the planet, leading to various environmental and societal impacts.



To address this rising issue, Vikas Sahyog Kendra has taken initiatives such as limiting deforestation, conserving forest area, and planting trees, among other things. We established forest management committees in five villages in the Chattarpur block, and two villages have a forest management plan.

Education

In recent years, one of Vikas Sahyog Kendra's primary priorities has been to ensure quality education. This year, we have visited government schools and held sessions with children across our project region to encourage them to attend school. We identified school dropouts, interacted with their families, and re-enrolled them in school.

SUCCESS STORIES

Regularized PDS distribution at Sarauna village under Tukbera Gram Panchayat

Sarauna village comes under Tukbera gram panchayat which has a total 180 households including 98 PH card holders & 7 AAY card holders. There is no running ration dealer shop in the village. Villagers generally go to Basna panchayat to avail PDS supplies.

As a part of the project objective, from the very start we have been intervening in this village & has been creating awareness among the villagers regarding Gram Sabha & Panchayati Raj. Gradually, when Gram Sabha became more frequent in Sarauna and people began convening in Gram Sabha to discuss various concerns as well as take action, the issue of insufficient ration supplies was raised and addressed in Gram Sabha. It has been identified that the ration dealer is only providing the villagers with 4.5 kg per unit of ration in quantity where as they are entitled to have 5 kgs. The villagers has been told by the dealer that only 4.5 kg per ration is allocated for them, The villagers could not raise their voice & this unjust phenomenon has been going there for quiet some time. The villagers discussed this problem in a Gram Sabha meeting, and they agreed to band together to voice their concerns to the appropriate government official in order to regularize the PDS system in their area. The ration dealer was pressed by the locals, and an application was also made by the villagers, noting the matter and pleading with the MO to take appropriate action against the dealer.



As a consequence, the government official took action, and the villages began to get adequate supplies. After two months, when the dealer began to deliver less ration once again, the villagers again stepped forward to halt it, while pressuring the dealer to file a complaint directly to the District Collector. With all of these efforts and via Gram Sabha meetings, the villagers were able to resolve the issue of PDS supply, and they have received regular PDS supplies in right quantities for the previous four months.

The people of Rajhara village entitled with PM - Awas Yojna

Rajhara village is part of the Rajhara panchayat and is around 15 km from the Nawa-Bazar block development office. CCL (Central Coalfields Ltd.) mining sites surround the community. As a result, the people of Rajhara were unable to reap the advantages of the PM-Awas Yojna since they were told that the whole area of their village was included in the property acquired by CCL.

We have been interacting with the community and holding regular Gramme Sabha, Tola Sabha, and SHG group meetings since the project's beginning. The villagers' rising worry over land concerns in Rajhara was expressed multiple times in meetings. The villagers banded together, and preparations started to take action to resolve the situation and connect the people with the



PM-Awas Yojna. The villagers decided in a Gramme Sabha meeting to submit an application to the Manager of CCL, Rajhara Coal Mines, outlining all of the issues they were experiencing and requesting that the situation be resolved. The properly signed application was made, passed in Gramme Sabha, and forwarded to CCL.

As a result of this action taken by Gram Sabha in Rajhara, the PM-Awas yojna started in the village & almost 80 out of 100 household were successfully linked to the scheme & reaping out the benefits.
