Call to Order by Chairperson and Pledge of Allegiance: at 7:02 pm by Jonathan Spatz

Item 1: Minutes of Tuesday, January 17, 2023. Motion to approve made by Sarah, seconded by Vanessa. Motion was approved.

Item 2: Actions Re: Election of IT Supervisors 2023.

Dist. 1 Kara Novogradac Dist. 2 Nettie Owens Dist. 3 Emily Cook Dist. 4 Sarah Hertweck

Jonathan reported receiving Kara's regrets for not being present due to a family medical reason. IT Dist. 1 residents, Amy and Richard, signed Kara's nomination petition for the primary election for IT Supervisor. IT Dist. 2 residents, Vanessa and Ron, signed Nettie's nomination petition for the primary election for IT Supervisor. Emily already had nine signatures on her nomination petition, and Sarah was fully in control of the progress of her nomination petition.

Ron and Vanessa led discussion of the procedure for prospective candidates to complete the Commonwealth of Pennsylvania "Statement of Financial Interests" that can be filled in online at: <u>https://www.ethics.pa.gov/How-</u>

Richard referred to the filling instruction: Kara, Nettie, Emily and Sarah must file a <u>copy</u> of this document with their nomination petition. The original gets filed with the secretary of Indiana township before May 1st. Jon offered his help to all filling the forms.

Vanessa showed everyone the County of Allegheny "Candidate Affidavit and Ethics Law Information" form that prospective candidate must file along with their nomination petition.

Motion: For the committee to endorse Ron and Vanessa for FCA school board candidates, and Kara, Nettie, Emily and Sarah as candidates for township supervisor. Proposer: Jim, seconder Phil. **Motion carried** unanimously.

It was suggested that the candidates might post their picture and a bio in the ITDC website and on the ITDC Facebook page. Email the pictures and bios to Jim for insertion on the website.

It was agreed to file the nomination petitions along with the Ethics Affidavit and a copy of the Financial Interest Statement, by February 27 to allow time to correct any defects. Jonathan offered to take the petitions to the county building downtown, if he could have the eight petitions in hand by Sunday February 26th.

Item 3. Discussion of Allegheny County Elections 2023.

There was a brief review of the candidates attending these local DC meetings: Shaler Jan. 15 -- Michael Lamb, Erin McClelland, Anthony DeLuca. O'Hara Feb. 9 – Andy Szefi, Erica Brusselars, Matt Dugan, Cory O'Connor, Patrick Sweeney. (Bob Gallo and Anita Prizio spoke on behalf of John Weinstein and Sara Innamorato. Hampton Feb. 15 – Liv Bennet, Dave Fawcett, Sara Innamorato, Michael Lamb, Erin McLelland, John Weistein. Richard had circulated a good writeup of the Hampton forum: Democratic candidates for Allegheny County executive gather at North Hills forum - Pittsburgh Union Progress

It was agreed the committee would itself not endorse any particular candidate for office.

Richard asked what other county candidate meetings were set up, Jonathan forwarded the ACDC email listing forthcoming meetings. Locally -- Shaler, February 19; Fox Chapel, February 21; McCandless February 23; Pine, February 26.

Item 4. Community picnic plans for August 26, 2023

Jonathan reported the committee has reserved the Gazebo and Old Mill Dam Pavilion for the picnic, from noon to dusk that Saturday. Ron said the picnic time should be set from 2:00 PM to 5:00 PM. There was a brief discussion about activates for the picnic. The consensus was to repeat last year's bounce castle, hot dogs and drinks, and encourage candidates and our newly elected officials to attend. Perhaps add live music. Nettie will see if the FC Chorus might perform. Amy suggested advertising the picnic in the township newsletter. Vanessa's suggestion was to publicize the picnic door-to-door with door hangers. Funding the picnic budget was discussed. The cost last years was about four thousand dollars, mainly for printing and mailing invites, the bounce house, and rushed ITDC tee shirts. Jim suggested we ask supporters to contribute \$25 to ITDC through the ActBlue link on our website.

Item 5. Treasurer's report. Jim Mitnick reported the only expenditure since last month was \$200 for rent of the gazebo and pavilion for the picnic. The current bank balance is \$1,289.00

Jim reported that the committee must file financial reports with the Pennsylvania Department of State. Names and addresses of donors who sent us checks are required, also a "POLITICAL COMMITTEE REGISTRATION STATEMENT"
