## THIS CONTRACT IS FOR A STUD SERVICE.

A deposit is required prior to collecting, the remaining balance is due 24 hours prior to shipping semen / day of breeding. If any outstanding fees for shipping are not paid, Litter registration papers will not be released. \_\_\_\_\_ Initials

## DEFINITION OF "LITTER"

A Litter, for the purposes of this Contract, is defined as a minimum of 2 puppies born alive. If Litter results in only one puppy, and the Female Owner does not wish to repeat the Breeding, the deposit paid prior to Breeding, plus expenses, will be considered payment for a one puppy Litter and the Contract is fulfilled. Birth by caesarean section or as recommended by veterinarian. If Female Owner does not follow vet's advice and puppies pass away during at home birth then the two puppy guarantee no longer applies and no rebreed. NO refunds or partial refunds for Dam not becoming pregnant, Dam being sold, Dam not having a large enough litter, etc.

## NOTIFICATION REQUIREMENTS:

The Female Owner is required to notify the Stud Owner on the first day the Female begins her heat cycle. The Stud Owner must also be notified on the day progesterone testing begins, as well as provided with the results of each progesterone test as they are obtained. Timely communication of this information is essential to ensure breeding occurs at the optimal time. Failure to provide accurate and prompt updates may affect the success of the breeding, for which the Stud Owner cannot be held responsible.

## STUD OWNER AGREES TO:

1. Provide the Female owner with a copy of the stud's AKC certificate.
2. Have the stud dog in good physical condition, with health testing.
3. Sign litter registration promptly when the Female owner registers the litter.
4. The contract is for the original insemination. Should the dam not have a live birth, stud owner will provide an additional semen specimen at the soonest available heat that is recommended for the owner (Female Owner will be responsible for collection & shipping charges). Should the dam not conceive and have a live birth after the second insemination, the contract is fulfilled.
5. Agree to cross post images and videos of resulting puppies from breeding.

## DAM OWNER AGREES TO:

1. Promptly pay the agreed-upon stud fee as well as all shipping charges (*should any be due*) related to the stud services, as outlined in this contract.
2. Provide the stud owner with a copy of the Female's AKC certificate.
3. Provide the stud owner with a copy of the Female's health testing.
4. Female Owner warrants that this Female has not been exposed to any other Stud Dog from the start of her heat cycle.
5. It is the sole responsibility of the Female's Owner to monitor and provide accurate progesterone testing for the Female. This ensures that breeding occurs at the correct and optimal time. The Stud Owner shall not be held responsible for unsuccessful breedings resulting from failure to properly track or report progesterone levels.
6. Provide the stud owner with the Veterinarian name, physical address and phone number. (*PHYSICAL ADDRESS - accessible to receive mail - make sure you verify*)

The semen will be shipped to your Vets / Repro Office at the Female Owners expense. The Female Owner understands that the shipping and collection fees will still need to be paid prior to shipping semen. \_\_\_\_\_ INITIAL

**\*Please take into consideration - Next day shipping +\$300 (if collected on Saturday, will not arrive until Monday, cannot be collected on Sunday)**

**\*Same day shipping +\$500 (Will need to be notified 24 hrs. In advance, cannot be collected on Sunday)**

7. Have the Dam in good physical condition and health testing.

8. Notify Stud dog owner, in writing, no later than 50 days after insemination if there are no pregnancy results. Failure to do so will result in no return service being provided.
9. Keep the dam properly confined following the breeding to ensure no other dog could mate her accidentally before mating season is finished.

Female Owner is responsible for all testing done to the dam prior to and during breeding to assure the proper timing of said breeding. If the Female Owner is not willing to pay for progesterone testing, smears or AI's, this should be stated ahead of time and included in the contract and initiated by both parties. If this is the case, the deposit is forfeited and no repeat breeding is offered.

Paid Stud fees and locks are **NON REFUNDABLE.** \_\_\_\_\_ (Initial)

It is understood that this contract only applies to the original buyer and is non-transferrable.

Once the package leaves us we are *not liable* for any unexpected delays that may occur during transit. \_\_\_\_\_ (Initial)
