There is more than adequate parking in outlet mall lots. There is an approx. 1.5 acre compacted dirt "vendor only" parking lot across from the venue location for trucks, vans, trailers. There will be a buyer "hold and loading" area a few yards from the market.

**IMPORTANT DATES/TIMES:**

**Vendors will be assigned load in time slots, schedule to be announced. Vendors will be able to pull up to their booth spaces during load in period ONLY. After load in, Vendor will be directed to the “vendor only” dirt lot across the street. Night security will be provided.**

**THURSDAY, SEPTEMBER 29:** Vendor early load in available from 2pm-8pm ONLY

**FRIDAY, SEPTEMBER 30:** Vendor load in from 6am-12pm ONLY/ Vendor luncheon and meeting 12:00pm-1:30pm (Free food & drink served)/ Open to public 3pm-9pm ONLY

**SATURDAY, OCTOBER 1:** Open to public 8am-4pm ONLY/Vendor load out 4:30pm-10:30pm ONLY

**IMPORTANT NOTES:**

- We do not provide tables, backdrops, rugs or partitions; vendors will be required to provide their own. We highly recommend shade cover (EZ up or?) for your booth.
- We will provide a 110v power plug for a single fan if desired and MANDATORY booth lighting. Friday night will be dusk-dark from approx. 7:00pm-9:00pm. YOU WILL NEED BOOTH LIGHTING!! The lot is lit, however, parking lot lighting is NOT SUFFICIENT for your booth to be easily visible to buyers.
- Tables must be covered with cloth, burlap or any other full cover to the ground. Exposed tables will not be permitted.



**-We also encourage you to promote your own business/sales by signage, banners and placing your personal cards at your booth.**

**-We encourage you to send us any and all social media info for your business so that we may also promote you before , during and after our markets. Our goal is to help you promote your business, not just at our market but all year long!**

**TERMS , CONDITIONS & REGULATIONS:**

1. 'STUFF with STORIES' , its agents, officers or employees, shall not be liable for property damage or personal injury to vendor, its agents or employees, which may occur on or about any part of the subject premises, regardless of how much injury or damage may have occurred. Vendor waives any claim against 'STUFF with STORIES' and assumes all liability for loss or damage to Vendor property entrusted to the premises. Exhibitor shall hold 'STUFF with STORIES' harmless and shall indemnify 'STUFF with STORIES' against all liability or expenses arising out of any claim of injury or damage to any person or property, together with all costs in connection with the defense thereto, including attorney's fees.

2. 'STUFF with STORIES' reserves the right to make rules and regulations it deems proper and necessary, and vendor agrees to accept such rules and regulations and any interpretation as is set forth by 'STUFF with STORIES'.

3. This contract cannot be assigned without the prior written consent of 'STUFF with STORIES'. No booths may be shared without the prior consent of 'STUFF with STORIES'.

4. The use of help, to assist unloading and loading is at vendors' own risk, and 'STUFF with STORIES' shall not be liable for any resulting injury or claim.

5. Cancellation policy: Booth Space Rental Fees will NOT be returned if Vendor cancels for any reason.

Should this show be cancelled by "STUFF with STORIES Vintage Market" for any reason, this contract is null and void, and vendor waives any and all claims, except booth space rental fee return. Rain or any other inclement weather will NOT cancel the show or cause refund of fees.
