INFORMED CONSENT AND WAIVER/ RELEASE

I, the undersigned, as the event organizer listed on this application in consideration of the request and permission of my family and guests to use Lifeguard For Hire employees including, but not limited to Swimming Pool Parties, Swimming Pool Events, and/ or Swim Lessons, hereby assume full responsibility for all risks of injury or loss which may result from my family's and/ or guest's participation in this activity and hereby agree to hold harmless, release and forever discharge Lifeguard For Hire, it's officers, agents, and employees from and waive any and all claims and demands whatsoever which the undersigned and any of them or any third person of any accidents, illness, injury, or death of any person and persons, or damage to or loss or destruction of any property arising or resulting from swimming, a variety of strenuous exercises, vigorous physical activities and/or running directly or indirectly from my family's and/ or guest's participation in the aforementioned program and occurring during said participation or any time subsequent thereto, save and except that the above provisions shall not be applicable to injury to or death of person's or damage to or loss of property arising out of the sole negligent acts or omissions of Lifeguard For Hire, their officers, agents or employees. The terms of this release shall serve as a release and assumption of risk for my family, heirs, executors, and administrators and for all guests.

I understand, agree, and acknowledge that there are risks inherent in the sports activities conducted by Lifeguard For Hire, including water aerobics classes, including, but not limited to paralyzing injuries, brain injuries, and death. These activities may be of a hazardous nature and/ or may include activities such as swimming, a variety of strenuous exercise, and vigorous physical activities. With the full understanding of the facts, I state, that to the best of my knowledge, my family and/ or guest listed on this application has no medical, physical, mental, or emotional health condition which would hinder or prevent his/ her active participation in Lifeguard For Hire programs.

I understand, agree, and acknowledge that the Lifeguard For Hire employee(s) is there for water safety. They are responsible for only the area directly around the pool or relating to the pool. The Lifeguard For Hire employee(s) has the final say on safety and I support all their decisions in this regard. I also understand that if safety becomes too much of an issue and the Lifeguard For Hire employee(s) is uncomfortable and/ or does not receive my support, they will leave the Swimming Pool Party(s), Swimming Pool Event(s), and/ or Swim Lessons along with collecting payment in full regardless of in the scheduled time has been met or not.
