

## SALTY BONITO CHARTERS LLC "TAINA DEL MAR" Liability Release Form

The undersigned individual, (the "Charter Guest"), will be a charter guest on the vessel TAINA DEL MAR, a 2022 27-foot "Sea Hunt Gamefish 27" Documented Number DO1326987 (the "Vessel"), owned by SALTY BONITO CHARTERS LLC, a Florida limited liability company (the "Owner").

In consideration for the permission to have access to, and remain onboard the Vessel during charters and related activities, which may include without limitation, fishing, cruising, swimming, snorkeling, SCUBA diving, and other watersports ("Charter Activities"), the Charter Guest hereby executes this Liability Release Form (the "Release") as follows:

The Charter Guest understands that Charter Activities involve certain risks, including without limitation, serious injury and death.

THE CHARTER GUEST AND THEIR AGENTS, EMPLOYEES, AUTHORIZED REPRESENTATIVES, AND ANY OTHER PERSON CLAIMING BY, UNDER, OR THROUGH THE CHARTER GUEST, HEREBY VOLUNTARILY RELEASE THE VESSEL, THE VESSEL'S MASTER AND CREW MEMBERS, THE OWNER, OR THE OWNER'S OFFICERS, DIRECTORS, AND SHAREHOLDERS, EMPLOYEES AGENTS AND SUBCONTRACTORS (COLLECTIVELY, THE "RELEASED PARTIES"), AGAINST AND FROM ANY CLAIMS OR CAUSE OF ACTION OF ANY KIND THAT THE CHARTER GUEST MAY HAVE OR ACQUIRE ARISING FROM PARTICIPATION IN VESSEL CHARTER ACTIVITIES, INCLUDING, WITHOUT LIMITATION, ANY CLAIM OR CAUSE OF ACTION ARISING FROM THE NEGLIGENCE OF ANY OF THE RELEASED PARTIES.

This Release is governed in accordance with the federal maritime law of the United States and the law of the State of Florida, and is binding on my heirs, executors, administrators, personal representatives, and assigns. A signed copy of this Release sent by email, facsimile, or other electronic means will be deemed an original for all purposes.
