Jason gave an update on the grants that have been submitted and approved or not approved. Alpine Creek Hazardous Fuels Reduction Phase 1 is coming to a close soon. Phase 2 has been approved and will be funded for \$525,000.00 includes 23 additional parcels continuing at the end of Phase 1 and going down to Puetz Valley bowl.

Tavern Road Evacuation Route has also been approved for \$85,000.00 and will be heard at the San Diego River Conservancy meeting in November.

SPFMG Grants are still working hard to keep up on requests for DSAP. Roadside chipping is going well and overall numbers are increasing. To date of these minutes (10/2) a total of 538,888 cubic feet of piles have been chipped for a count of 270 registered residents. There are 3 events remaining in 2025.

Operation CHIP DROP #3 will occur on 10/11/2025 from 8:00-11:00 at Viejas Rec Center. Adam will be there with the tractor to help compact. ECTLC will be there to volunteer to help assist homeowners with unloading. Jon Winslow and Bonnie will be in position to run the event.

Balentine Team Lead Jim Peck has a pop-up event occurring after Alpine Fire Open House at 3:00.

Jim Peck suggested I make a list to help homeowners with the "triggers" on when will the inspection occur for Zone 0. Examples are: AB38 Real Estate Inspection, County permits, burn permits, HIZ, a request for an inspection by the public, a complaint called in from a resident.
