

LAUREN B DESIGNS
CONSIGNMENT CONTRACT

This agreement is made between you, _____, (the consignor) and Lauren B Designs.

The consignor and Lauren B Designs acknowledge and agree that the consignor has provided goods described that meet all quality conditions listed below. These items are being placed for sale on a consignment basis, under the terms and conditions of this agreement:

1. Lauren B Designs agrees to pay the consignor 70% of the final sale price less taxes.
2. Consignor agrees to the following condition standards:
 - a. No stains, outdated styling, holes, missing buttons or hooks, loose buttons or hooks, broken zippers, pilling, fading, loose or torn hems, or torn seams.
 - b. Providing items that have been cleaned, wrinkle free, odor free and pet hair free.
 - c. If the consignment items are in need of repair, Lauren B Designs offers repair and cleaning services. All costs of repairs and cleaning MUST be paid in full prior to items being placed on consignment.
3. All items must be in one of the following conditions: New with Tags, Nearly New, Excellent, Good w/ Minor Flaw (must note flaw in item description)
4. In order to attract and keep a higher caliber of clientele, Lauren B Designs reserves the right to accept or decline merchandise they deem appropriate for the store.
5. Lauren B Designs agrees to use its best efforts to sell the goods in a timely matter and for the highest price possible.
6. If you have a minimum price you will accept for the items being consigned you must notify us on the item list and it must be pre-approved by a staff member of Lauren B Designs. If not, Lauren B Designs will determine the selling price of all items based on age, condition, brand, style, size and demand. We reserve the right to refuse the items if we do not feel we can obtain your asking price.
7. The consignment agreement is based on a one (1) year period, although either party may terminate this agreement with a thirty (30) day written notice given to the other. Merchandise picked up by the consignor prior to the one year or without a 30 day written notice will be subject to a \$50.00 fee.
8. On day 366 of consignment, the consignor then has the option of donating to Lauren B Designs or picking up the item(s). On the 366th day an attempt will be made to contact the consigner, via email, regarding the item(s) that have not been sold. This is only a courtesy email. You are responsible for noting the day of pick-up. Item(s) must be picked up within 5 days of notification or items will automatically become property of Lauren B Designs WITHOUT FURTHER NOTICE. You will be given a 7 day window, as WE DO NOT ALLOW PICK-UPS SATURDAYS, SUNDAYS, OR MONDAYS.
9. An option to renew the agreement for an additional six (6) months will be at the discretion of Lauren B Designs.
10. Checks will be issued on the first (1st) of the month for any consignment items sold within the previous month. Checks will be written out to the name on the consignment contract. You will be notified of the sale and to pick-up your check. You will have 15 days from date of notification to pick up your check. Checks not picked up within 15 days will be cancelled and will not be re-issued. Checks must be picked up by the consignor who's name is on the contract. Lauren B Designs will not give checks to friends or family members of the consignor.
11. Lauren B Designs is a formal dress and accessory broker and cannot hold insurance for inventory it does not own. We are careful and trustworthy but assume NO liability for fire, flood, theft, damage or wear. The items are being handled and tried on and some wear should be expected at time of pick-up.

12. The terms and conditions of this contract will remain in effect until further notice.
13. If any part of this agreement is adjudged invalid, illegal or unenforceable, the remaining parts shall not be affected and shall remain in full force and effect.
14. This agreement shall be binding upon the parties, and upon their heirs, executors, personal representatives, administrators and assigns. No person shall have a right or cause of action arising out of or resulting from this agreement except those who are parties to it and their successors in interest.
15. This agreement, including any attached exhibits and addenda, constitutes the entire agreement of the parties. No representatives or promises have been made except those that are set out in this agreement. The agreement may not be modified except in writing signed by all of the parties.
16. Please note that on some occasions we may run a 20% off sale. If your dress sells during this time, 20% off will be taken off the final price.
17. The dress and or other items must not be listed for sale anywhere else during period of contract.
18. If you wish to consign your dress and you are under 18 years of age, a parent or guardian must sign the consignment contract. We will not accept consignment items from minors.
19. Consignor agrees to share Lauren B Designs via word of mouth and social media posts especially posts with consignor's items to advertise within the community.
