Consignment Rental Policies

PAYMENTS

All rentals must be paid in full before the rental agreement can be final and your rental secured on the calendar. Lauren B Designs does not accept checks for rentals. Alterations are not included in dress rental price.

ALL PAYMENTS ARE NONREFUNDABLE

RENTAL DURATION

RENTALS ARE TO BE PICKED UP THE DAY BEFORE YOUR EVENT AND MUST BE RETURNED THE DAY AFTER YOUR EVENT BY CLOSE OF BUSINESS.

NO EXCEPTIONS. A LATE CHARGE OF \$50 A DAY WILL BE APPLIED. Alteration appointments for customers are scheduled based on the return day of the dress.

THE DRESS CAN NOT BE LATE OR YOU WILL BE CHARGED.

CLEANING

All dresses/accessories must be returned clean and free of stains and body odor. All items returned will be assessed and an additional cleaning fee will be charged if required. DO NOT DRY CLEAN DRESSES OR ATTEMPT TO REMOVE STAINS, additional fees will incur.

ALTERATIONS

Dresses/accessories may not be altered to fit by anyone other than Lauren B Designs. All items must be returned in their original condition. Alteration prices are NOT included in rental fees. If a dress/accessory is returned altered or damaged, fees will be charged. Dresses/accessories may NOT be cut, dyed, painted, or altered without written permission from Lauren B Designs. Tape, iron-on bonding-web, glue or any other type of adhesives may NOT be used on dresses/accessories.

DAMAGED OR LOST ITEM FEES

Normal wear on dresses/accessories is expected and will not incur extra charges. Damage beyond normal wear will incur damage charges above the rental fee. ALL RENTAL DRESSES/ ACCESSORIES WILL BE INSPECTED AFTER RETURN. ANY PERMANENT DAMAGE TO ANY DRESS/ACCESSORY REQUIRES THE PURCHASE OF THE DRESS/ACCESSORY.

Damage charges will be assessed for broken zippers, detached garment pieces, make-up or other permanent stains or any other damage that renders the dress/accessory not rentable. Charges include the cost of the supplies needed to restore the garment to its original state and labor costs. Major damage to dresses/accessories, including irreparable tears, or irreversible marks will be assessed at the replacement value of the dress. Lost dresses/accessories will be assessed with a lost dress/accessory fee of the replacement value of the dress/accessory.

A credit card number will be required to be placed on file for the duration of the dress rental. No charges will placed on the credit card unless the consignment item(s) are not returned or returned damaged beyond repair.
