Board

The South Carolina Legislature is working on a bill right now to amend current code of laws in SC to add the South Carolina Homeowners Association Act. We the BOD, feel S30 has elements that are not good for homeowners and not good for community associations. A motion was made back in August to make mandatory that golf carts have lot #s on them. This did not make it to the rules or website because of a question on where to put it. A motion was made at this month's meeting that now shows the rule to be a new item 10 as shown below. In the future, the Board will determine at motion passing where to put the item in the rules.

The Board has become concerned that large vehicles, including our maintenance equipment and emergency trucks, have difficulty traveling our circle streets. This is made worse when residents/owners place large items and their vehicles near the edges of the blacktop.

Recently, we have had the Horry County Fire Department evaluate the situation and were told that we have a serious problem in the event of a fire or other disaster which requires large equipment. It is the intention of the Board to improve this situation as much as possible considering the layout of our Circles.

First, a special committee surveyed the circles and recommended changes to the islands. As a result, several trees have been removed and some of the islands are being reconfigured. Also, you may have noticed that some of the trees and plants close to the blacktop have been trimmed. All property owners should be aware that the POA owns approximately 3' on each side of the blacktop. You can determine exactly how much if you locate the front corner stakes of your lot(s).

The next step is to free the POA property along the blacktop circles. First, please do not allow anyone to park a vehicle within 3' of the blacktop. Second, do not place large objects including basketball hoops, landscaping, etc. in this same space. We have asked that the GAC, Maintenance and Security Committees advise where such violations exist so the Board can take appropriate action. It is our intention to issue warning letters followed by fines, when necessary.
