## **TELEPHONE SERVICE**

## **MOTORIZED VEHICLES AND GOLF CARTS**

No motorized vehicle may be operated on any roads on the Property by **anyone not old enough to obtain a drivers license**. All vehicles must be in good working order and not used after dark without working lights.

## **NEW REGULATION**

No discharge of any firearm or projectile shall be permitted on Village property. This will include, but not be limited to, paint ball guns, BB or pellet guns, dart guns, slingshots, any type of fireworks, or any other object which has the potential to injure, threaten, or endanger life, property, or the personal safety and well-being of the property owners, residents, and guests of the Village. This policy will be **strictly enforced** against all property owners, residents, and their guests. Any hunting or target practice is strictly forbidden. These restrictions do not preclude or alter County enforcement of any act of endangerment committed on private property.

## **ARCHITECTURAL AND TREE REQUESTS**

Residents should be aware that filling out an Architectural Approval Request or Tree Removal Request gives the Board of Directors and its agents permission to enter their property to conduct the business requested. A statement to this effect will be added to these forms.
