Private Lots & Homes, Item N should now read, "Personal Watercraft and their trailers, ATVs or their trailers shall not be kept, stored or parked on any lot, road or common property except the storage compound or in a garage for more than one night per month. Upon violation be notified and subject to fines. Kayaks and unmotored watercraft or surfboards small enough to be easily carried by one person and transported on a car roof rack can be neatly stored on the side or rear of the house if placed in an inconspicuous place or covered as to not distract from the neighborhood. 

#### **Security Committee Annual Report**

We made a lot of positive adjustments to our security equipment; computers and cameras have been updated. We installed a license plate reader at the front gate to allow us to monitor all cars entering the village. We have had a few problems with the gates being hit, but we have been able to collect for the repairs on each incident. The laser on the bar code reader has been replaced. Most of the problems in the village have been effectively handled by deactivating the cards of the responsible families. Cards have been deactivated for inappropriate activities in the all age's game room and pool rule violations; word of the deactivations spread quickly and amenities are running quite well.

An ongoing problem that has lately come to attention is speeding in the Village. Recently, we have received several complaints about cars driving around the village at high speeds. These cars have been located, and we are in the process of trying to stop this. However, these vehicular issues are difficult to prove, and we get very little support from the Horry County Police. The village needs to document vehicular issue, but the police need to catch the speeders in the act before they can take action. The residents of WJV must be held accountable for their guests; we need all the residents to help with these problems by reporting the issue in the form of a concern. ### **Maintenance Committee Annual Report**

Maintenance has had another very active year and has gone through some changes. One of the biggest changes, was the unplanned departure of Jeff, who decided to move back home to Minnesota. He was loved by many in the Village; we miss him and wish him well. After an intense and time-consuming search, Robert Horn was chosen by a combined committee of personnel, maintenance volunteers, and board members. Robert has jumped into the position with a new outlook of shaping up the Village.

Maintenance, along with our great staff of volunteers has been involved with many of the changes of the other village committees such Beautification, Security, Social, Recreation, Fire & Disaster, Library, as well as keeping up with our everyday needs. Almost everything that is done in the Village involves Maintenance and our Volunteers. This committee provides our great amenities with unheard of low POA fees.

We have recently completed another phase of our ongoing Village repaving project. Roadways are one of the largest costs for any; luckily for WJV, a committee, with the advice of many experts, evolved a plan to repave the village in stages. The first year, the worst spots in the Village were replaced, then clubhouse parking lot and main entrance; the front half of Little River Drive was another large undertaking; last year we re-paved the circle entrances and added curbs. This year we have started to repave the actual circles after careful planning and study of storm drainage. Future phases of the plan continue to repave the circle roads and correct any outstanding storm drainage issues.

Another great improvement this year was the ionization of our pool to best make use of our pool budget under DHEC's newly revised regulations. Ionization is a very simple process of combining copper and silver with a very small electrical charge to ionize the water, greatly reducing our chemical needs. I truly believe the pool has never been as nice and pure as it has been this year and hopefully will be for years to come. *Charlie Nill*
