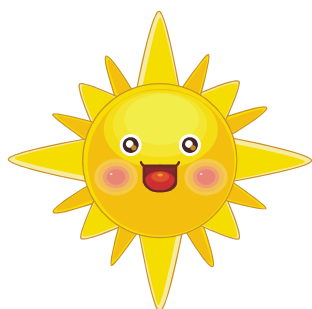

## BOARD

We were able to accomplish quite a lot of business during the first meeting of the new board of directors. Two amendments to the Windjammer Restrictions, Rules, and Regulations were passed. Under Section III. REAL PROPERTIES, Sub-Section 1. Village - General, a paragraph was added to state:

i. No Windjammer Village funds shall be spent on alcoholic beverages. No alcoholic beverages shall be stored on common property. No alcoholic beverages will be served by anyone acting on behalf of Windjammer Village.

To be clear, this rule does not restrict the consumption of alcohol at Windjammer Village events. In the future, any alcohol consumed at a village event must be of the BYOB variety.

Under Section II. ROADWAYS, the following item was added:

10. Any vehicle designed for use on major public highways must be operated in accordance with all SC and DMV rules and regulations when used anywhere on common property in Windjammer Village.

Such rules include but are not limited to:

- a. Current Vehicle Registration and Insurance
- b. Valid Driver's License or Permit [see [www.scdmvonline.com](http://www.scdmvonline.com)]
- c. Property owner of violators residence will be subject to a fine from Windjammer Village Board of Directors.

Because our Village roads are private property, this rule simply makes clear that the same traffic laws that apply outside the Windjammer Village property apply within Windjammer Village property.

Both of these amendments were added to help reduce the Village's liability risks. We live in a great place with great people. However, in these litigious times, the board feels that we must take efforts to reduce the Village's exposure to civil and criminal lawsuits.

## ARCHITECTURAL.

12 items – Eight were approved by Architectural. Board vote needed on four. Dish antenna on Brunswick; reduction in dues from \$66 to \$46 for lot with house removed on Swamp Fox; installation of berm and crushed stone to divert water on Lafayette; and new home construction on Dykman – all approved by Board. **Ken Mayo, Chair**

## **COMPOUND**

After many hours I feel that I am now close to having a correct accounting of Compound spaces. There are 153 total spaces in the Compound. There are 36 vacant spaces; 2 owners with 3 spaces; 17 owners with 2 spaces; and 76 owners with 1 space. There is 1 space where I have not identified the owner. Therefore there are 96 owners who make use of the Compound.

There have been some rumors circulating about the Compound. To clarify: 1. All spaces must have a signed Assignment Agreement regardless of where they are located in the Compound and whether the owner has more than one space; 2. There will be a fall registration. I have been collecting email addresses for assignees in hopes of doing the fall registration by email. I now have email addresses for 74 of the 96 assignees, leaving 22 that will need to be filled out by mail or dropped at the Office. I do not plan to do an onsite re-registration at the Compound.

In the near future fines will be levied for untidy lots and lack of identification. If re-registration is not completed by November 1, space contents will be towed. I spoke to the towing company and there will be a \$200 impound fee and a \$30 per day storage fee. Several changes have been made to the Compound Registration Form. The new form is available on our web site and in the Office. **Alex Hughes, liaison**

## **SECURITY**

The phones and internet connection were inoperable for about two days. Time Warner corrected these problems. Two circuit boards in the gates were burned out. Charlie Nill ordered new parts and installed them. The gates were left open for about a week while repairs were made. One bicycle was reported stolen. Horry County police were notified and a report was filed. No arrest has been made. A group of 4 teens threw rocks at a resident's house and damaged his front door while trying to break in.
