






























Thanks for the overwhelming response!!!!!!!! Can you match the babies to their names?

NOTES FROM Board of Directors

Please be aware of the following:

Only residential/household trash is allowed to be disposed of in our waste containers. Residential/household trash is defined as trash in a tall kitchen trash bag. Do not leave items outside of the trash bins. Take items you feel may benefit others to a local charity or perhaps list for sale in a local marketplace. The Village is subject to fines from Waste Management for illegal dumping. Residents are subject to a fine for disposal of non-household trash, as well as the additional cost the Village incurs for disposing of the material properly.

Do not close the doors on the recycle bin. Maintenance rakes the recyclable material to level it out if the bin appears to be full in one area. The bin should be filled to capacity when emptied. The Village is charged the same rate for a half full bin as a full bin.

Picnics at the pool involving more than 10 people require a permit. See the RRR for the pool party guidelines. You must dispose of the party trash properly in waste containers by shell island. The raccoons get into the trash and make a mess when trash is left in the pool area.

If you use the gate by the basketball courts to enter Vereen Park, **do not leave the gate unlocked** during your walk in the park. Lock the gate as you enter Vereen Park and make sure to also lock the gate when you return to the Village. Maintenance and Security are finding the gate unlocked far too often. We suspect non-residents are entering the Village to use our facilities.

We continue to see children swinging on the rope at the pool. The rope is a safety feature. The pool has to be closed if the rope is not in place. It is costly to repair and/or replace the rope.

We would also like to remind our residents the Board nor staff at WJV reviews Facebook for concerns. Please turn in a concern to have the issue addressed properly. The Board would like to promote communication and transparency. We welcome your comments and the opportunity to address our issues.

The Windjammer Village Board of Directors meeting was called to order by President, Bobby Kardack, at 7:04pm in the clubhouse. Board Members present: Brian Kardack, Anna Marie Farr, and Dianne Sarles. Vickie Lynch was not present. The Pledge of Allegiance was recited.

Minutes from May 15, 2025, Board of Directors meeting was read by Secretary Liz Eby. Dianne Sarles made a motion to approve May 15, 2025, minutes. Second by Anna Marie Farr. Motion carried.

TREASURER'S REPORT:

None

STANDING COMMITTEES:

Reports received from the Architectural, Budget and Finance, Hospitality, Long Range Planning, Maintenance and Social Committees have been attached to make them part of the minutes.

ARCHITECTURAL:

Anna Marie Farr made a motion to approve the installation of a gate to connect the end of the fence to the shed at 2232 Dykman Circle (C16). Second made by Dianne Sarles. Motion carried.

Anna Marie Farr made a motion to approve the installation of a 6' tall scalloped top privacy fence and 6' tall four board farm style vinyl fence at 2224 Jefferson Circle (H12-13-14). Second made by Brian Kardack. Motion carried.

Dianne Sarles made a motion to approve the installation of a 12' x 60' x 4' high black aluminum fence on the back side of the house at 2134 Lafayette Circle (G16-17). Second made by Anna Marie Farr. Motion carried.

TREES:

Anna Marie Farr made a motion to approve the removal of 6 trees that were previously approved in June 2024 but were not removed at 2219 Dykman Circle (C38-39-40). Second made by Brian Kardack, Motion carried.

Anna Marie Farr made a motion to approve the removal of 1 Loblolly Pine at back of home, 1 Holly tree at back of house, 1 Laurel Oak on the right side of house, 1 Cedar tree on the right side of house, 2 Sweet Gum tree on the right side of house and 2 Dogwood trees on the right side of the house. Trees are a danger to the foundation and rotten at 2134 Lafayette Circle (G16-17). Second made by Brian Kardack. Motion carried.

Dianne Sarles made a motion to approve the removal of 1 Holly tree that is constantly causing debris in the front yard of the house at 2166 Marion Circle (E32-33). Second made by Brian Kardack. Motion carried.

Anna Marie Farr made a motion to approve the removal of 2 dead Oak trees, 2 Pine trees dropping sap on vehicles in the front yard and grind a total of 8 stumps at 2198 Gamecock Circle (B24). Second made by Brian Kardack. Motion carried.

OLD CONCERNS:

2135 Lafayette Circle (G28) – Stairs need repair, sent letters to owner, no response. Has been fined \$100.00 hasn't paid fine or repaired stairs.

 Anna Marie Farr made a motion to fine the homeowner \$200.00 and send a letter to both addresses. Second made by Dianne Sarles. Motion carried.

2228 Jackson Circle (D12-14) - Failure to clean up yard. Sent letter to owner, no response.

Thursday, June 19, 2025

Brian Kardack made a motion to fine the homeowner \$100.00 for failing to clean up the yard. Second made by Anna Marie Farr. Motion carried.

NEW CONCERNS:

2134 Brunswick Circle (L17-18) – Storage container on property for over a year. Homeowner says he had permission to have the storage container on property for an extended time.

 Dianne Sarles made a motion to hold over to the July meeting and the homeowner is asked to provide a timeline of when storage container will be removed. Second made by Brian Kardack. Motion carried.

2118 Brunswick Circle (L09) - Child in pool with diaper on

Dianne Sarles made a motion to send an email to all WJV residents reminding them of the
pool rules stated in the R/R/R's of no diaper dependent adults or children in the big pool. If
a concern is turned in for anyone not following the rules the homeowner will be fined.
 Second by Anna Marie Farr. Motion carried.

2236 Franklin Circle (I18) - Parking vehicle in yard, entering from Little River Drive (black/dark blue vehicle). Homeowner responded he doesn't have a dark blue/black vehicle.

 Brian Kardack made a motion to fine the homeowner \$100.00 for vehicle entering from Little River Drive. Second made by Anna Marie Farr. Motion carried.

2236 Franklin Circle (I18) - Entering property from Little River Drive.

2 concerns were received for same offense, homeowner will only receive one fine.

2245 Jackson Circle (D36-37) – Owner has an old wood pile on neighbors' property. Wood pile is infested with termites. Neighbor has asked owner to remove the wood pile but neighbor won't remove.

 Anna Marie Farr made a motion to hold over until July 2025 meeting so BOD can contact owner. Second made by Dianne Sarles. Motion carried.

Diaper dependent children in big pool – Approximately 8-month old and 1 year old. Woman was asked by resident to read the sign regarding no diaper dependent children in the pool. Woman took children to the kids pool then brought back to big pool. (Don't know who the woman was).

adults or children in the big pool. If a concern is turned in for anyone not following the rules

Security Cameras not working

TJ Snyder responded to the above questions. WJV currently has 7 working cameras, they are working on getting 15-16 cameras working in the next couple of days. The cameras are transmitting but not recording. Several security companies have been out to quote a system and they unplug and plug our current system into theirs to see if it is compatible and don't know if cameras were plugged in again when they were done. We will no longer be using Integrity for our security system. Security Vision will be coming in to help get system up and running again but WJV will maintain the system and can call Security Vision for assistance if needed.

Caribbean Tenderloin with Peach Salsa

1½ - 2-pound Pork Tenderloin (usually 2 in a pack)

Marinade:

4 Tbsp. Olive Oil

2 Tbsp. Brown Sugar

2 Tbsp. Caribbean/Jamaican Jerk Seasoning

2 Tbsp. Dried Thyme (leaves)

2 Tbsp. Dried Rosemary

Combine and marinade tenderloins for at least 2 hours

Peach Salsa:

2 C. Fresh Jimmy Cox peaches, peeled and diced

1 small red pepper, chopped

2 Cloves garlic minced

¼ C. red onion

1.2-1 Jalapeno, seeded and minced

1-2 Tbsp. Honey

1-2 Tbsp. fresh Lime Juice

½ tsp. lime zest

4 Tbsp. chopped fresh cilantro

Seasoned or Kosher salt and pepper to taste

Combine and refrigerate for at least an hour

Grill tenderloins to and internal temperature of 135. Cover with foil and let rest for 5 minutes.

Slice and serve with Salsa. Sounds AWESOME!!
