

**Guests of family relation** - to permanent camper are allowed to stay at In The Pines Seasonal Camp-Resort with or without them in their camping unit.

**Guests unrelated to Tenant** - are not allowed to reside at Tenants campsite without Tenant present during the duration of the stay. All Tenants guests need to be registered through the TEKWave system at the start of visit. Tenant's guests need to use their own e-pass to open the gate.

**Office hours** - are from 9 am – 5 pm Tuesday through Saturday. If Tenants Guests arrive after office hours, Tenant needs to register guests through the guest registration system prior to their arrival.

**Safety and Quiet Hours** - Golf carts and vehicles are to be driven responsibly and on roads only – no cutting through campsites or driving on the grass. Golf carts can only be driven if you have a valid driver's license. **Speed limit in the park is 5 miles per hour. Quiet hours in the park are from 10:00 p.m. to 8:00 a.m.**

**Campfires** - must be attended at all times. All fires must be kept within the fire pit, fire ring or fireplace. All fires must be extinguished prior to leaving the property. During time of fire restrictions, no fires of any type are permitted.

**Firewood** - Is not allowed to be brought into Wisconsin from another state and all firewood must be bought within Juneau County to control the spread of disease. Firewood is sold on site for your convenience.

**Littering** - is prohibited in every area of the campground.

**No off-the-ground fireworks** - of any kind allowed in the Campground. This will allow for immediate dismissal of park.

**Please be respectful** - of others privacy, and campground property. All guests are required to conduct themselves in a respectable manner.

**Pets** - must be kept on a leash, cleaned up after and not left unattended. No pets allowed in tiki bar, pool, laundry or restroom, and any other public building. Owner's are responsible for any claim, loss or damage caused by their pet(s). All pets must have proof of current vaccinations on file in the office prior to coming into the campground. **Parking** is limited to the site you are assigned. If there is not enough room, you must park extra vehicles in the public parking lot near the front entrance.

**Pool Rules** - No lifeguard on duty, swim at your own risk. Liner may be slippery – so be careful! Diving and rough play is prohibited. No pets allowed in pool area. No glass containers allowed. All children under the age of 14 must be accompanied by an adult. No solo swimming.

**Neither In The Pines Seasonal Camp-Resort it's officers, staff, enrollees, guests or all other persons and entities which may sponsor, promote, operate, own or manage the campground shall be liable to any attendees for injury to person or property incurred as a result of attendance. You will be required to sign above as a Waiver and Release of Liability to your admission to the campground.**
