1. TICKET PURCHASE AGREEMENT

By purchasing a ticket to this event, you acknowledge and agree that:

- You are entering a private, organized sporting event
- Participation is subject to all rules, waivers, and safety requirements
- Entry is not guaranteed until all required documents are completed and approved

2. FINAL SALE POLICY (NO REFUNDS)

All ticket purchases are:

- Final and non-refundable
- Non-transferable unless explicitly approved by event staff
- Not eligible for chargeback due to policy acceptance at checkout

Refunds will NOT be issued for:

- Failure to meet requirements
- Failure to complete waivers
- Removal from event due to rule violations
- Late arrival or no-show
- Weather or operational adjustments unless event is fully canceled

3. WAIVER REQUIREMENT

All participants must complete and sign the official:

- Player Waiver & Liability Agreement
- Safety Rules Acknowledgment

Failure to complete required documentation:

- Results in denied entry without refund

4. AGE & ELIGIBILITY REQUIREMENTS

Participants must be 16 years or older

Valid government-issued ID is required at check-in

Misrepresentation of age or identity will result in removal without refund

5. TAGinn GRENADE PURCHASE TERMS (IF APPLICABLE)

If purchasing TAGinn grenades:

- Valid P-TOP certification is required
- Must match name on purchase and ID at event check-in
- Must be picked up in person at the event only
- No shipping is available under any circumstances

Failure to meet requirements results in:

- Forfeiture of product with no refund

6. EVENT ENTRY CONDITIONS

Entry into the event is conditional upon:

- Completion of all required waivers
- Compliance with safety rules and equipment standards
- Approval by event staff at check-in

Event staff reserves the right to deny entry for safety or compliance reasons.

7. RULE COMPLIANCE AGREEMENT

By completing purchase, you agree to:

- Follow all Speedsoft and/or MILSIM rules
- Comply with referee instructions at all times
- Use approved equipment only
- Maintain sportsmanlike conduct

Violations may result in:

- Removal from gameplay
- Disqualification from event
- Forfeiture of ticket without refund
