**PLAYER SAFETY RULES  
WAIVER & PARTICIPATION AGREEMENT**

**Event: Halloween Aftermath Charity Tournament**  
**Beneficiary: Veterans Advocacy Group**  
**Organizer: Red Spectre Training Group**

**1. ACKNOWLEDGMENT OF RISK**

I understand that participation in airsoft and simulated combat activities involves inherent risks, including but not limited to:

- Impact from airsoft projectiles (including close-range engagement)
- Physical exertion, dehydration, heat exposure, and environmental hazards
- Slips, trips, falls, and collisions with terrain or structures
- Use of pyrotechnic and simulated explosive devices (including TAGinn grenades)
- Equipment malfunction or misuse

I voluntarily assume all risks associated with participation, whether known or unknown.

**2. ELIGIBILITY & PARTICIPATION REQUIREMENTS**

By participating, I confirm:

- I am 18 years of age or older
- I am physically and mentally capable of participating
- I am not under the influence of drugs or alcohol
- I will comply with all event rules, safety standards, and referee instructions

Failure to meet these requirements may result in denial of entry or removal without refund.

### **3. REQUIRED SAFETY EQUIPMENT**

#### 3.1 Mandatory for ALL Participants

- Full-seal ANSI-rated eye protection
- Full face protection (mask or equivalent)
- Appropriate clothing to reduce injury risk

#### 3.2 Speedsoft Division Requirements

- Full face protection (lower + upper) required at all times
- Lightweight, high-mobility gear recommended
- Gloves strongly recommended

#### 3.3 MILSIM Division Requirements

- Full face protection required (mesh + rated eye protection acceptable if approved)
- Tactical gear permitted (plate carriers, helmets, etc.)
- Additional protective equipment recommended due to extended play and terrain

Removal of required safety equipment during gameplay will result in immediate removal from the field.

### **4. GENERAL SAFETY RULES**

All participants agree to:

- No blind firing under any circumstances
- Maintain situational awareness at all times
- Follow all referee commands immediately
- Respect all field boundaries and restricted areas
- Handle all equipment safely at all times

Unsafe conduct may result in penalties, removal, or disqualification.

## **5. ENGAGEMENT & HIT CONDUCT**

All hits must be honored immediately and honestly

- When hit:
  - Raise hand immediately
  - Exit the field safely without delay

STRICTLY PROHIBITED:

- Dead shooting (firing after being hit)
- Using your body as a shield while exiting
- Overshooting or excessive firing on eliminated players

Violations may result in:

- Player removal
- Round forfeiture
- Disqualification

## **6. TAGINN GRENADE & PYROTECHNIC POLICY**

### 6.1 Certification Requirement

- Only players with a valid TAGinn P-TOP certification may purchase or use TAGinn grenades

### 6.2 Purchase & Pickup Policy

- TAGinn grenades purchased during pre-sale:
  - Must be picked up in person at the event
  - Require:
    - Valid government-issued ID
    - Matching name on purchase
    - Valid P-TOP certification

Failure to meet requirements:

- Forfeiture of grenades with NO refund

### 6.3 Usage Rules

- Grenades may only be used in designated areas and approved game modes
- Must be used in a safe and controlled manner
- Throwing directly at players is prohibited (ground/area use only unless otherwise approved)

#### 6.4 Restrictions

- No minors may purchase TAGinn grenades
- Unauthorized or unsafe use will result in:
  - Immediate confiscation
  - Removal from event
  - Possible disqualification

### 7. DIVISION-SPECIFIC RULES

#### 7.1 Speedsoft Division

- Semi-auto only
- No minimum engagement distance
- Single primary weapon only
- No riot shields
- No grenades or launchers
- Fast-paced, close-quarters gameplay

#### 7.2 MILSIM Division

- Tactical gameplay allowed
- Launchers permitted ONLY if mounted to primary platform
- Longer engagement distances expected
- Objective-based and role-driven gameplay

All players must comply with division-specific rules in addition to general safety standards.

### 8. PROHIBITED CONDUCT

The following are strictly prohibited:

- Physical aggression or fighting
- Verbal abuse, harassment, or threats
- Cheating or failure to call hits
- Tampering with field structures or game equipment
- Use of unauthorized or unsafe equipment
- Disrespect toward staff, players, or spectators

Violations may result in:

- Immediate removal
- Disqualification
- Event ban

## **9. MEDICAL ACKNOWLEDGMENT & CONSENT**

I confirm that I am physically fit to participate.

In the event of injury:

- I authorize event staff to provide basic first aid
- I consent to emergency medical treatment if necessary

I accept full responsibility for any medical costs incurred.

-Referees have full authority to:

- Issue penalties

- Stop gameplay for safety

Failure to comply will result in removal without refund.

### **13. NO REFUND POLICY**

- All ticket sales and purchases are final and non-refundable
- Failure to comply with rules or requirements does not qualify for a refund

### **14. LEGAL TERMS**

#### 14.1 Governing Law

This agreement is governed by the laws of the State of Florida.

#### 14.2 Severability

If any provision of this agreement is found invalid, all remaining provisions remain in effect.
