Louie Jung met with the Board about the building he is putting up. It had been measured to fit within the setbacks the City has requested for properties through their ordinances, but it now is going to be over by a foot. Hettick moved and Lehr seconded to approve the additional foot variance. All aye. Motion carried.

Bids were opened for the three concrete projects. Bids were from CWF Concrete & Masonry out of Aberdeen. Prices were: cold storage - \$10,000.02; ball field/concession - \$44,642.94; multi-sport court - \$157,566.61. Lehr moved and M. Bauman seconded to reject the bids and revamp the specifications to include slope and any other additional information needed. All aye. Motion carried.

Specifications for a new city office building were discussed. A new spec page will be put together from the discussion.

Specifications for a new bathroom building and ball field storage were discussed. A new spec page will be drawn up from the discussion.

Nathan Miller reported to the Board:

- Working on sewer jetter, fixing it up; maintenance done on all equipment.

There had been some question/concerns brought up about cleaning of snow being done by the city at the catholic church. Discussion was held on snow cleaning for non-profit organizations. Treichel moved and Lehr seconded to agree that if snow removal is done for catholic church parking lot, snow removal also needs to happen at Lutheran church parking area and legion parking area, with payloader. All aye. Motion carried.

Discussion was held on using the Volvo payloader for snow removal. We are waiting for it to be auctioned off and the arrival of new payloader, but if Roscoe were to receive 6+ inches of snow that the snow plow is needed, as the snow plow attachment doesn't work with the rental payloader, the Volvo payloader can be used.

A complaint about cats and dogs has been brought forth to the City. There have been many cats running around, and the complaint stems from said cats getting into a crawl space under a residence. This same residence has been also having issues with neighbor's dogs running loose. A letter is to be sent to the neighbors about the animals, and further action will be looked into if needed.

A possible 5-year plan was looked at. More information is needed, and will be added to it, for budget time.

Digital/mobile app time clocks were discussed. More information and pricing is needed.

Meeting pay for the board members was discussed. Each member is paid for the meetings in which they attend, but it was brought up about not receiving the full amount if they only call in. It was also brought up about more pay for the vice-president when they have to take over the duties of the president for more than just a meeting, or a one-time event.

Code enforcement was discussed. Board members were updated on upcoming actions.

FO Bauman updated the board on the lead line inventory for the DANR and EPA. Fliers were sent out to a portion of the water accounts with their latest bill.

Hettick moved and Lehr seconded to approve the 2nd reading of the revised City Ordinances, passing Ordinance #387 AN ORDINANCE IN REVISION OF THE MUNICIPAL ORDINANCES OF THE CITY OF ROSCOE, SOUTH DAKOTA. All aye, absent D. Bauman. Motion carried.
