D. Bauman moved and M. Bauman seconded to approve the agenda. All aye. Motion carried.

M. Bauman moved and Hettick seconded to approve the minutes of the December 22, 2023, meeting. All aye. Motion carried.

D. Bauman moved and Hettick seconded to approve the December Financial Statement and bank reconciliations. All aye. Motion carried.

FO Bauman brought up setting up a 5-year spending plan, keeping track of items that might need replacing or future large purchases that will need to be made in the future. Items were discussed to be put on the plan. A draft will be created for the next meeting.

RESOLUTION 2024-1

RESOLUTION ESTABLISHING CONTRACT FOR LEGAL SERVICES

WHEREAS, the City of Roscoe by and through its duly elected trustees hereinafter referred to as "City of Roscoe" deems it necessary to contract with a licensed attorney and/or law firm to provide legal services to the City of Roscoe.

Any contract for legal services with an attorney shall be made by ordinance or resolution. Such contract shall set forth the compensation to be paid and the specific services to be rendered."

WHEREAS, the City of Roscoe has decided to enter into a contract for a City Attorney for legal services at \$285.00 per hour.

NOW, THEREFORE, BE IT RESOLVED, that the City of Roscoe hereby contracts with the law firm of Bantz, Gosch & Cremer, L.L.C., to provide legal services to the City of Roscoe from January 1, 2024, to December 31, 2024.
