The Roscoe City Trustee Board met in a special session in the City Office with President Treichel presiding. Members present were, Lehr, D. Bauman, and M. Bauman. Others present: Bruce Schroeder. Absent: Hettick.

D. Bauman moved and M. Bauman seconded to approve the agenda. All aye. Motion carried.

Bruce Schroeder with SD Dept of Transportation met with the Board about the state highways running through Roscoe being put on the State's STIP plan. Highway 12 is scheduled for 2029 and highway 247 for 2031. As the dates get closer, more information will be available and work for detours will happen.
