D. Bauman moved and Lehr seconded to approve the agenda. All aye. Motion carried.

D. Bauman moved and Lehr seconded to approve the 2025 renewal of health insurance through Health Pool of South Dakota for Jim Fonder, Nicole Bauman, and Nathan Miller. The increase in premium was 7.4%, or \$62.47, for a new monthly premium of \$906.67. All aye. Motion carried.

Discussion held on work hours and if there needs to be any change for winter. No action taken.

President Treichel presented to Trustee Dale Hettick and Maintenance-man James Fonder, awards for SDML Hall of Fame, after their many years of service for the City of Roscoe. Hettick has been a council/board member for 22 years and Fonder has been with the city for 34 years.

An update on the work for the new city office building was given. Majority of the work is expected to be completed this month.

- Board will wait to decide on "renting" out the meeting area for other uses once the building is complete.
- Discussion was held on what to do about the existing office building once everything has been moved over. No action taken.

President Treichel discussed with the Board paintings by former resident George Hammond to be given to the City by Keith Schurr after his retirement.

Nathan Miller spoke with the Board

- He had lined up for Spring, crews to fix hydrants and some gate valves.
- Discussed 2025 purchase of steam/pressure washer will look for more options to present
- Discussion on tower maintenance

From previous discussion, more employee shirts and sweatshirts or jackets will be looked at for purchase.

An update with given for code enforcement. Next steps were discussed as final dates for legal actions were given.

FO Bauman reported to the Board:

- The 2025 insurance renewal packet is in, if any of the Board members want to look at it to see if any valuations should be changed.
- -FO Bauman has received some communication about possible right-of-way vacations. This may also be a time for the City to look at other properties that should be cleared up in terms of right-of-way vacates or if an easement is needed.
- As discussed at September's meeting, pay dates were adjusted to better work with direct deposit at the bank. The personal policy will be updated to reflect these changes.
