Water Use Charge per 1,000 Gallons

January – March \$ 14.64	April – June \$ 21.96
July – September \$ 29.27	October – December \$ 14.64
RI Water Resource Board \$0.0292 per 100 gallons	
RI sales tax on commercial account only: 7%	

Monthly Water Customer Charge:

Determined annually on July 1st by:

- a) The total billed water usage of the previous calendar year, and
- b) The months the billed water usage occurred during the previous calendar year.

- \$11.04/month. Low Impact 1 - If the account has an annual usage of less than 73,000 gallons and less than 65% of that use occurs between June-September
- \$18.50/month. High Impact 1 - If the account has an annual usage of greater than or equal to 73,000 gallons and less than 65% of that use occurs between June-September
- \$27.65/month. Low Impact 2 - If the account has an annual usage of less than 73,000 gallons and greater than or equal to 65% of that use occurs between June-September
- \$46.08/month. High Impact 2 - If the account has an annual usage of greater than or equal to 73,000 gallons and greater than or equal to 65% of that use occurs between June-September

Over Usage Penalty Charge: Based on total gallon used July – September only, \$55.00 / 1,000 gallons over account allocation.

Water Allocation	\$ 9.09 per gallon per day, paid in advance.
Sprinkler Service	\$ 1,391.50 per annum
Fire Flow Test	\$ 50.00 per occurrence, must receive Permit from Water Superintendent.
Hydrants	\$500.00 per annual
Standby Service	Based on previous year's 3 rd Quarter gallonage usage: 100,000 – 125,000 gallons: \$494.50 per quarter 126,000 – 475,000 gallons: \$741.75 per quarter 476,000 gallons and greater: \$989.00 per quarter

Accounts are payable by the end of the month in which the bill is received.
 Interest – 18% per annum, charged 1.5% monthly on accounts unpaid by end of month.

OTHER WATER CHARGES

Seasonal meter	\$ 50.00 per on site visit, turn on/off service and install/remove meter
Backflow Device Test	\$ 80.00 per test
Meter Testing/Reading	\$ 35.00 per on site visit
Frozen Meter	\$ 50.00 per event plus cost of meter and parts.
New Account	\$ 35.00 per connection plus cost of parts; we supervise installation.
Permit Fee	\$ 35.00 each
Inspection Fee	\$ 35.00 per connection per visit.
Tapping fees (Water)	1" tap is \$600 plus materials; 2" tap is \$800 plus materials
