Sl. No.	The school is directed to ensure that:
1	The total number of sections of Bal Vatika shall be restricted to 06 (two sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to XII shall be restricted to 30 of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by law and availability of class rooms of greater than 500 sq ft dimension.
2	The school is required to obtain water test report from Govt. authorized laboratory within 03 months and submit the same in the compliance.
3	The school is required to submit the copy of conversion letter of land measuring 24.41 dec, 66.60 dec, 64.40 dec and 80.00 dec (which are mentioned in the land certificate) in the compliance within 03 months.
4	The school is using bucket for water to drain in the biology, chemistry and composite science lab, which is not appropriate. Thus, the school is required to make the proper drainage system in the said labs within 03 months and submit the compliance.

5	The school is required to upgrade the furniture in the library and make the proper reading arrangement for students with proper seating and create separate reading space for staff within 03 months and submit the compliance.
6	The school is required upgrade the indoor game room and outdoor game facilities in light of Board's SoP within 03 months and submit the compliance.
7	The school has constructed a ramp to access the upper floors, but it is very steep and does not seem to be navigable by a wheelchair-bound student/staff. The school seems to have overlaid it over a stair case. thus, the school is required to dismantle the same and construct ramp/ lift to access upper floors with proper incline and safety features as per the provisions laid down in RPWD Act and Board's guidelines within 03 months and submit the compliance
8	The school shall conduct training of its teachers with CoE Bhubaneswar within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
