

Cottonwood Camp is an established RV, lodging, and outfitter business catering to fishing enthusiasts on the Bighorn River.

Numerous income sources include lodging, RV and tent spaces, fly shop, fishing guide service, and shuttle service.

The camp is located less than a mile from the Lind Access boat ramp at mile 3 on the Bighorn River.

It is the only lodging in the area to offer kitchens, drawing outdoor enthusiasts and families seeking freedom and flexibility.

Cottonwood Camp has been in operation for over 35 years.

75% of the camp's visitors are return clients with currently no advertising other than limited advertising to fly fishing enthusiasts.

Extensive capital improvements exceeding \$500,000 have been completed during the past 5 years.

Billings MT Airport is 90 minutes away with direct flights to Denver, Salt Lake City, Seattle, Dallas - Ft Worth, Minneapolis, and Portland (depart Denver at 8 AM, be on the river by lunch time).

Fort Smith's 3,800 foot airfield is located 3 miles from the property.












LOCAL MAP // Cottonwood Camp



THE BIGHORN RIVER

The Bighorn River is well-known throughout the world for the superb fly fishing it offers. The first thirteen miles-from Afterbay Access to Bighorn Access-have more trout per mile and a bigger average trout size than any other river in Montana. You probably have a better chance of catching a trout over 20 inches on the Bighorn than on any other river in Montana. Bighorn trout are extremely healthy because of the river's excellent food supply. They are wonderful fighters and very acrobatic. Dry fly fishing, nymphing, and fishing streamers can all be productive for much of the year. The Bighorn River is open and very fishable the entire year.

FORT SMITH AND BIGHORN NATIONAL RECREATION AREA

Fort Smith is located in Big Horn County in the southeast region of Montana. The area is popular for outdoor lovers, history buffs, fossil finders and eager explorers. The scenic Big Horn, Pryor and Wolf Mountain ranges are part of the Big Horn County landscape. Fort Smith is home to Bighorn Lake, which extends approximately 60 miles through Wyoming and Montana, 55 miles of which are held within the spectacular Bighorn Canyon Recreation Area.

Bighorn Canyon Recreation Area is composed of over 120,000 acres, which straddles the northern Wyoming and southern Montana borders. Within the area is the Devil's Canyon Overlook providing breathtaking views and cliffs that tower 1,000 feet above the lake level. Bighorn Canyon National Recreation Area boasts breathtaking scenery, countless varieties of wildlife, and abundant recreational opportunities such as boating, fishing, hunting, magnificent vistas, wildlife watching, camping, biking and hiking. Visitors choose from over 17 miles of trails, ranging from short walks to dramatic overlooks, and boaters marvel at the awe inspiring views of the massive canyon walls. Travelers can find information about the area's attractions at the visitor center in Fort Smith.


