

Supernova All Star Cheer Waiver and Release of Liability

In consideration of _____, my minor child/ ward ("My Child"), being allowed to participate in any way in the Supernova All Star Cheer program, related events, competitions, and activities, the undersigned acknowledges, appreciates and agrees that:

1. Cheerleading are vigorous sporting activities involving height and rotation in a unique environment and, as such, pose a significant risk of injury. Cheerleading and related activities always involve certain risks, including, but not limited to death, serious neck and spinal injuries and serious injury to bones, joints and muscles. The risk of such harm may be limited by safety equipment and coaches, but will never be eliminated;
2. For myself, spouse and My Child, I knowingly and freely assume all such risks, both known and unknown, and even if arising from negligence of Supernova All Star Cheer or others, and assume full responsibility for My Child's participation;
3. I willingly agree to comply with Supernova All Star Cheer standards and customary terms and conditions for participation in Supernova All Star Cheer programs. If I observe any unusual and significant concern in My Child's readiness for participation and/ or in the Supernova All Star Cheer program itself, I will remove My Child from participation and bring such issue to the attention of the nearest Supernova All Star Cheer Board Member or Adult Coach immediately.
4. I, myself, my spouse, My Child and on behalf of my/ our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE SUPERNOVA ALL STAR CHEER AND THEIR RESPECTIVE EMPLOYEES, COACHES, MEMBERS, OFFICERS, AGENTS, CONTRACTORS, SUBCONTRACTORS, AND OTHER PROGRAM PARTICIPANTS, SPONSORING AGENCIES, SPONSORS, ADVERTISERS, AND IF APPLICABLE, OWNERS AND LESSORS OR PREMISES USED TO CONDUCT SUPERNOVA ALL STAR CHEER PROGRAMS ("Releases"), with respect to any and all injury, disability, death or loss or damage to personal property incident to My Child's involvement or participation in Supernova All Star Cheer programs, whether arising from the negligence of the Releases or otherwise, to the fullest extent permitted by law, and
5. I, for myself, my spouse, My Child and on behalf of my/ our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS AND COVENANT NOT TO SUE all above Releases, from any and all liabilities incident to participation and involvement in Supernova All Star Cheer programs, even if arising from the negligence of Releases, to the fullest extent permitted by law.
6. The novel coronavirus, COVID 19, has been declared a world-wide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. Supernova All Star Cheer has put in place preventative measures to reduce the spread of COVID-19; however, the gym cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the gym could increase your risk and your child(ren)'s risk of contracting COVID-19. By signing this agreement, I, for myself, my spouse, My Child and on behalf of my/our heirs, assigns, personal representatives and next of kin, acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the gym and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the gym may result from the actions, omissions, or negligence of myself and others, including, but not limited to, gym employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my/my child(ren)'s attendance at Supernova All Star Cheer or participation in gym programs. I, for myself, my spouse, My Child and on behalf of my/ our heirs, assigns, personal representatives and next of kin, I hereby release, covenant not to sue, discharge, and hold harmless the Releases of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the gym, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any gym program.
