Partnership Event Contract

This agreement is made between **Pause For Paws Animal Sanctuary**, a nonprofit organization, and the undersigned **Partner Venue** ("Partner") for the purpose of hosting a collaborative fundraising event.

1. Event Overview

Pause For Paws Animal Sanctuary will:

- **Promote the event for 1 week** prior, using street teams to distribute promotional materials within and up to a 5-mile radius. (2 to 3 miles in a more dense environment)
- **Design and produce** all flyers, posters, and event signage.
- **Assist to Staff the event** and manage its flow and engagement.

The Partner will:

- **Host a 2–4 hour event** on a preferred date and time of their choosing.
- Allow event promotion on-site and assist with basic setup permissions.

Section III – Termination Clause

Either party may terminate this agreement **in writing** with a minimum of **72 hours' notice** prior to the scheduled event date, without penalty or further obligation. Notice must be provided via email or signed letter to the primary point of contact for the other party.

Section III – Termination Clause - (Continued)

In the event of termination within fewer than 72 hours of the scheduled event:

- The terminating party shall make a **good faith effort** to notify the other party as soon as reasonably possible.
- If Pause For Paws has incurred out-of-pocket expenses for printed materials or promotional efforts specific to the Partner's event, the Partner agrees to either:
 1. Proceed with a rescheduled event within 30 calendar days

-OR-

2. Reimburse documented material costs not exceeding **\$100 USD**.

This agreement may also be terminated immediately by either party in the case of:

- Unsafe conditions, credible threat to staff or animals

-OR-

- Any act or omission that constitutes a breach of the terms herein.
