



Limited, Transferable Lifetime Warranty

Summit Epoxy Floors (SEF) installs custom resinous coatings on existing substrates. As these floors are custom installations, color and pattern matching are not guaranteed. Complete flake coverage of fibrous, wooden, or metallic inlays in the floor is not guaranteed. Resinous floors require a porous surface for permanent bonding, so this warranty is not applicable to overlays on non-porous surfaces including previously sealed or painted surfaces, metals, plastics, or any other non-porous surface.

With limited exceptions for wooden, phosphorescent (glow-in-the-dark), and fluorescent (black light reactive) color flakes, color flakes and top coat materials are color stable and not impacted by ultra violet light.

This Limited Warranty (Warranty) is made in lieu of, and exclusive to, all other warranties, express or implied.

EXCEPT FOR THE EXPRESS WARRANTIES CONTAINED IN THIS WARRANTY, SUMMIT EPOXY FLOORS DISCLAIMS ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

In the event applicable law prohibits the disclaimer of any implied warranty, all such implied warranties shall be limited in duration to the term of the Warranty. SEF's sole obligation to Customer, and Customer's sole and exclusive remedy with respect to the Warranty, is to provide labor and materials necessary to repair, replace, or provide a full or partial refund, at SEF's exclusive option, for any defect covered by this Warranty. SEF is not liable for personal injury from a slip and fall, or any other incidental, special, or punitive damages relating to a claim under this Warranty. This Warranty is transferable a new homeowner with limits outlined below. This Warranty is voided if payment is not received in full as mutually agreed.

SEF's warrants installed interior residential floor coatings for as long as the original purchaser owns the home or, if transferred to another homeowner, for a period of 15 years from date of installation. Commercial, exterior, public access, or heavy use applications are warranted for a period of 5 years from the date of installation. All installations are warranted against: (1) delamination; (2) flaking; (3) peeling; (4) hot tire pick-up; (5) staining from spills of oil, fluids, gasoline, and diesel that are promptly removed. The following are excluded: (1) peeling or delamination caused by moisture underneath the slab on which the floor coating was installed; (2) damage from acids; (3) staining from PCV pipe adhesive primer; (4) formation of new concrete cracks or changes to existing cracks, repaired or not; (5) damaged caused by abuse or neglect of floor coating; (6) inconsistent coverage or failures in coatings on fiberboard or metallic seem materials in concrete floors; or (7) inclusions in the finish including, but not limited to, bugs, leaves, dust, dirt, or debris that contacts the floor prior to completed curing.

SEF will spot repair, at no additional cost to Customer, any damaged areas covered by this Warranty.
