APPALOOSA HORSE CLUB PARTICIPANT'S AGREEMENT AND RELEASE OF ALL LIABILITY AND CLAIMS

NOTE: ALL RIDERS IN ALL GAMES CLASSES AT ApHC APPROVED SHOWS OR EVENTS ARE REQUIRED TO EXECUTE THIS RELEASE.

This Participant's Agreement and Release of All Liability and Claims ("Release") is executed by the undersigned person ("Participant") on the date and at the place set forth.

PARTICIPANT UNDERSTANDS THAT THE ApHC STRONGLY ENCOURAGES THE USE OF ASTM / SEI APPROVED PROTECTIVE HEAD GEAR IN ALL ApHC GAMES CLASSES AND THAT WEARING PROTECTIVE HEAD GEAR CAN PREVENT SERIOUS INJURY OR DEATH.

In consideration of being permitted to participate in games classes at Appaloosa Horse Club ("ApHC") approved / or sponsored horse shows or events, Participant, for himself or herself, and for his or her legal representatives, heirs, distributes, and assigns (collectively "Releasers"), hereby releases, waives, and discharges the ApHC, its affiliated organizations, including, but not limited to, show management, sponsors, promoters and advertisers, and the owners and lessees of any premises upon which any ApHC approved show or event is held; and each of them, their directors, officers, employees, agents, contractors, and members (collectively "Releases") of and from any and all liability, action, claim, demand, expense, loss, or damage of whatever kind of nature to Participant and Releasers arising from personal injuries, death, or property damage to Participant or others arising directly or indirectly from or attributable in any way to Participant's participation in a games class at any ApHC approved and / or sponsored horse show or event whether caused by the negligence, action, or omission of Releasees or any other cause; and hold harmless, indemnify and agree to defend ApHC Releasees from any and all claims arising from Participant's participation in any such games class.

PARTICIPANT IS AWARE THAT PARTICIPATION IN ApHC GAMES CLASSES IS AN INHERINTLY DANGEROUS, HAZARDOUS ACTIVITY AND PARTICIPANT VOLUNTARILY DESIRES TO PARTICIPATE IN THIS ACTIVITY WITH KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREES TO ACCEPT ANY AND ALL RISKS OF INJURY OR DEATH.

Participant, for himself and Releasers, agrees to indemnify Releasees, and each of them, from any loss, liability, damage, or cost they may incur due to Participant.

I HAVE CAREFULLY READ THIS RELEASE AND FULLY UNDERSTAND ITS CONTENTS. I INTEND THIS RELEASE TO BE BINDING ON ME AND RELEASERS. I AM RELEASING LEGAL RIGHTS THAT I MAY HAVE, AND SIGN THIS RELEASE OF MY OWN FREE WILL.
