#### **Position Summary**

This role will allow you to learn traffic control from the ground up. Flaggers at Trinity Traffic Control Inc. will travel throughout various cities along Colorado's Front Range with an experienced Traffic Control Supervisor (TCS). The TCS will teach you how properly lift, load and unload traffic control devices on and off trucks, as well as direct traffic through job-sites, set up lane closures, operate arrow boards and message boards and work safely in and around work zones. This is a foundational position in the company and will be a spring-board for future advancement.

#### **Key Roles and Responsibilities**

- Assist with loading and unloading traffic control devices to and from trucks.
- Assist with setting up and taking down work zones that will protect workers and the travelling public.
- Deploy and setup arrow boards and message boards for work zones.
- Direct traffic safely around work zones using stop/slow paddles and hand signals.
- Follow all company and job-site safety rules and regulations
- Adhere to all Company Policies and Procedures
- All other duties as assigned

#### **Oualifications**

- You're reliable. You have a history of consistently coming to work on time, ready to go.
- You have verifiable professional and personal references.
- You own transportation to get to and from work.
- You are able to read, write and speak English—bilingual a plus (English / Spanish).
- You become Flagger Certified (we can train and certify you).
- You're willing to learn and willing to jump in and help.
- You must be able to take and follow directions and have strong communications skills.
- You can meet the physical requirements of the job (see below).

### **Working Environment/Physical Requirements**

- Work is performed outdoors in potentially extreme weather conditions / varying temperature, e.g., exposure to hot, cold, wet, humid, dry and / or windy conditions.
- **General Lift/Carry Expectations:** Must be able to lift a minimum of 30 lbs. constantly 50 lbs. maximum; occasionally 65 lbs. maximum
- **Standing:** Constant standing throughout the shift. Position may require standing for periods greater than two hours at a time, for a total of greater than eight hours.
- Walking: Occasional walking throughout shift to remain alert and to move with machinery
  involved in work-site project. Will periodically walk to put down and pick up safety cones and
  signs.
- **Sitting:** Occasional sitting for brief periods in vehicles when moving from one location to another. No sitting permitted when performing flagging duties.

- **Lifting/Carrying:** Constant handling of 24" aluminum Stop/Slow sign with PVC pipe weighing 4-5 lbs. Lift/carry rubber safety cones, weighing 10 lbs. each, intermittently throughout shift (load may be broken down by employee). Set-up and take down traffic control signs (maximum 30 lbs.) and stands (maximum 65 lbs.).
- **Reaching:** Constant reaching with one hand/arm to steady stop/slow paddle out in front of body. Constant reaching out in front of body with one arm to motion traffic. Constant raising and lowering paddle to full extension of arm. Position allows worker to alternate hands/arms at their discretion.
- **Stooping/Bending:** Occasional stooping/bending when putting down and picking up safety cones.
- **Twisting Wrists/Forearms:** Frequent twisting of wrist/forearm to turn stop/slow paddle from side to side. Position allows worker to alternate hands/arms at their discretion.
- **Grasping:** Constant grasping of stop/slow paddle one-handed (may alternate hands at own discretion).

**Work Settings/Description of Environmental Hazards Encountered:** Highways, city and county roads. Working around moving vehicles on roadways and around moving heavy equipment at road construction site

#### **Requirements**

- Pass pre-employment, random, post-accident, and reasonable suspicion drug screens
- Satisfactory results of pre-employment background check
