Lifting Station

Our neighborhood has an underground "lift station" that pumps waste water from Misty Oaks towards the waste water treatment plant. There have been problems with unusual items clogging the pumps which causes the pump to shut down. Manatee County has had to remove underwear, t-shirts, rags, socks and even towels from the pumps. These items Should Not be flushed down the toilet. Other items that should not be flushed down the toilet are "flushable wipes" which do not break down and clog the system, cat litter and plastic bags. Please do not flush these items down the toilet or any other non-flushable items.

Speeding

We have sent a letter to the Manatee County Traffic Management Division to request their help in finding a solution to control the speeding on our neighborhood streets. While MOST of the residents comply with the speed limit, many of the visitors,

service and delivery vehicles do not. For the safety of our residents, children and pets, we need to compel these people to drive safely in our neighborhood.

Our Deed Restrictions require you to obtain approval from the Board before you make changes to the exterior of your home. Please read the Deed Restrictions before planning your project to make the approval process smoother and easier.

Your request must be in writing to Jim McGuire, our Architectural Control Director. Please use the "Request for Modifications" form to expedite the processing of your request.

Please allow sufficient time for processing and approval before you plan to start your project.

These are some of the things that require approval:

- *Painting your home exterior with new colors*
- *Cutting down a tree or making major changes to your landscaping*
- *Adding on to your home*
- *Putting in a pool or lanai*
- *Installing brick pavers or new driveway surface*
- *Installing new windows, exterior doors or garage doors*
- *Putting on a new roof or changing materials*
