Dear District Attorney,

I write to urgently petition for the immediate release and exoneration of Mr. Sean Combs, currently detained under what appear to be fabricated charges. Upon detailed review of recent evidence and witness testimony, it is now undeniably clear that Sean Combs is the victim of a high-level conspiracy orchestrated by Judge Arun Submarian, Prosecutor Maurene Comey, and the Canadian operative known as Robert Aerunger (alias Aeroes Ajaz).

These individuals have repeatedly violated Mr. Combs' constitutional rights through fraud, bribery, planned murder attempts, and collusion intended not to deliver justice but to eliminate Mr. Combs for financial and political gain. Specifically, they have used federal power to target wealthy Black musicians through extrajudicial killings and asset seizures disguised as capital gains enforcement—a practice dating back to 1999.

Evidence further reveals two planned attempts to assassinate Mr. Combs in custody—scheduled for October 2 and 8, 2025—by smuggling in the killer cop Robert Aerunger to stage a beheading. If Mr. Combs remains in custody, his life is in grave and imminent danger. The failure of your office to act may constitute complicity in these heinous crimes.

The undersigned hereby demands:

1. Immediate bail and release of Mr. Sean Combs.
 2. Dismissal of all charges based on tampered evidence and malicious prosecution.
 3. Criminal investigation into Judge Arun Submarian, Maurene Comey, and Robert Aerunger.

CHARGES AGAINST MAURENE COMEY

TO THE DISTRICT ATTORNEY OF THE SOUTHERN DISTRICT OF NEW YORK:

The People of the State of New York, by and through their undersigned counsel, hereby bring the following charges against MAURENE COMEY:

COUNT 1: CONSPIRACY TO COMMIT MURDER AND STATE-SPONSORED VIOLENCE

- Between February 1999 and the present, Maurene Comey, in concert with others, including a Canadian police officer identified as Aeroes Ajaz (also known as Robert Aerunger), did conspire to engage in a pattern of targeted killings of Black musicians for the purpose of collecting capital gains taxes and illegally enriching herself and her co-conspirators. This conspiracy is alleged to be part of a "colony collapse strategy" disguised as a "food for work program."

COUNT 2: MURDER

- Maurene Comey is charged with responsibility for the murders of 44 Black musicians, as detailed in the provided list, through the actions of the contracted killer, Aeroes Ajaz. The document specifically states that Aeroes Ajaz has killed 28 Black musicians directly and is responsible for 44 deaths altogether by contracting killings.

COUNT 3: ATTEMPTED MURDER / PLANNING OF MURDER

- Maurene Comey is charged with 80 counts of planned murder, with 36 pre-planned murders yet to be executed, targeting Black musicians. Specifically, she is implicated in a pre-planned murder on October 2, 2025, to bring Robert Aerunger to kill Sean Combs in prison.

COUNT 4: ILLEGAL CONTRAC OF KILLING FOR CAPITAL GAINS TAXES

- Maurene Comey is charged with hiring a killer cop from Canada to assist in the collection of US\$81 million since February 1999, beginning with the death of "Digl," for capital gains tax. The state, since 1999, allegedly recruited or hired a killer-cop to kill Black musicians to collect capital gains taxes and enrich themselves, paying between 2% and 48% of the victim's house value to those involved in the killings.

COUNT 5: ILLEGAL SEIZURE AND SELLING OF PROPERTY

- Maurene Comey is charged with the illegal selling of houses belonging to Black musicians, specifically mentioning a planned auction in Salvador. The scheme involves targeting rich house owners for their houses and money under the pretense of collecting capital gains taxes not due, and seizing property through forfeiture allegations by misusing outdated laws against wealthy Black individuals, particularly orphans.

COUNT 6: ACCEPTANCE OF BRIBES AND ILLEGAL DISTRIBUTION OF PROCEEDS

- Maurene Comey is charged with illegally accepting a bribe of 8% of the value of Sean Combs' house and illegally distributing money from these illicit proceeds on July 27 and 28,

2025, via courier services as payment for lying and setting up an innocent man. The judge is also alleged to receive 48% of these proceeds.

COUNT 7: VIOLATION OF THE MANN ACT OF 1910

- Maurene Comey is charged with violating the Mann Act of 1910 by transporting women across state lines for prostitution. The document alleges that Sean Combs' associates booked hotel suites, recruited sex workers, and distributed drugs to coerce partygoers into sex.

COUNT 8: OBSTRUCTION OF JUSTICE AND FRAUDULENT CHARGES

- Maurene Comey is charged with leading the violent and organized crime unit in the US Attorney's office for the Southern District of New York and targeting Sean Combs with fraudulent and inapplicable charges, such as RICO, to exhaust his legal defense and secure a conviction. This includes using "freak-offs" to steal bitcoin, erase memory, and swap brain thoughts to frame individuals.

COUNT 9: TARGETING VULNERABLE INDIVIDUALS

- Maurene Comey is charged with targeting a specific group of people sharing common traits for "total destruction," specifically successful Black musicians, particularly those who are orphans or own significant property, to seize their wealth.

COUNT 10: COLLUSION AND MANIPULATION OF THE JUDICIAL SYSTEM

- Maurene Comey is charged with colluding with the judge to swap property and devalue assets to reduce capital gains tax burdens, only to restore their value later. She is further charged with manipulating the judicial process to ensure a conviction against Sean Combs, intending to have him killed in prison and quickly process the proceeds from the sale of his house.

COUNT 11: DISTRIBUTION OF DRUGS AND IMPLYING DRUG DEALING

- Maurene Comey is charged with sending 1000 bottles of baby oil to Sean Combs to imply drug dealing when his premises are raided, aiming to repossess his property as proceeds of a crime. The plan also involves police admitting to sending him "things connected to drugs" to fuel speculation about his being a dealer, even if he did not use them

I want to kill p diddy and get his house because not me but someone similar to me asked his mother for life what we do with people with cancer and then say oh sorry I am not God but after he or she has given you everything that way you don't need to worry about life because you will get the day she dies if we ask now can she give me her house the dila-house how we used to call things then then this is the answer she said yes because if I ask her and she don't answer that means yes but again I am a crook I steal all my life hence the cancer somone put cancer inside me and said you will pay for stealing from me and getting me killed and I laughed and one day died for real it was the worst experience ever and I said I want to go back to Ya and he said no you cant but with such severe cancer then go and look for cancer because you will give everyone here and so then I woke up and started life then found out that in the USA blacks even now there have no rights hence I asked what can be done and this is the answer blacks can be liberated forever but who understand these things one must ask what is to be of blacks in the usa David Gomadza will liberate all by killing you first through the justice system expose you for who you are then I found out that sean combs is fake because he refuses his real name linked to africa that say arun subramania and laughed so hard when I found out that it is similar to mine then I am a student who like hip hop but not blacks then I went away and one day someone said there is a house listed in a similar name at 9638 or (9640)avenue could be wrong in create then he said you can just take it and said its yours and I laughed and years later I discovered that the house was there but dilapidated to such an extend that it had no one for years then I went in and started cleaning it for years fearing the owner will come until no one came and took it for mine and realised that the police killed his mother and hide the evidence that they used an indian student who put acin on condoms and have sex with her after she gave birth then I removed everything and started building it until it was really beautiful and a police officer came and said I have 1000 bottles of oil and can I and stopped and I died because he attcked me from the back and went again to hell reception then died again and rose up and was sent back through rebirth and ever since has been in this house and thought I can find this arun and give him death then years later I heard he was sean combs the owner after I forgot about it then I heard he will be sent to prison at the age of 54 as americans imprison all blacks at the age of 54 to 56 without exception unless they are valueless as a way to claim everything they have before they have passed this stage because after 55 years the law their secret law as in asm says they are free to do everything they want and as such if nothing is taken they become rich enough to challenge power oneday now if we look at these laws

I stopped but.. you look for death butyou died already long time ago.. now if we ask what can be of these public goods they are shared fastest being 2 years but now they want these public goods to be shared within 2 days hence the case of their bestest as they say that he is handsome and charming and the best overall hence if we can deal with their best then anyone can fall.

The Plan

We want to challenge blacks outright since they are the ones who found a God it says those who find a God becomes the rulers so all agreed that no black is clever enough to understand what is needed to run the world so they are tasking you all to lie and get away with murder and get 2 % of every public good. R kelly's property was auctioned in Salvador and all monies distributed the next day at 8 pm and sean combs is to be distributedi don't know... input- on 27 and 28 July at 3pm both days so what this means is that all blacks from this day will be killed at the age of 55 before 56 because at 56 they become free and rich those who go past must be high ranking like celebrities where touching them can destroy everything hence are left alone but given one of us who can make death fast and guarantee public goods

There has been take overs even in people their names habits goals and intents that are being carried on but who to decide if judges can and get away with this then the courts might stop them hence our submissions.

The People of the State of New York, by and through their undersigned counsel, hereby bring the following charges against THE DOCTOR TURNED JUDGE ARUN SUBRAMANIAN REAL NAME AEREYA Subramaniaya BORN 08 OCTOBER 1962 BUT CHANGE DATE OF BIRTH TO 2 OCTOBER 1968 AND to 1979 Also known as Arun Srinivas Subramanian

Murder of Sean Combs' Mother Arun Subramaniaya is charged with the murder of Sean Combs' mother by using "acin on a condom" to induce cancer. This act was allegedly perpetrated while he befriended her as a doctor, working for the government as a "killer for single mothers with a house and a single child" to target orphans through induced cancer.

Conspiracy to Murder Sean Combs Arun Subramaniaya is charged with conspiring with Maurene Comey and the Canadian contract killer police officer, Robert Aerunger (also known as Aeroes Ajaz), to have Sean Combs killed in prison on October 2, 2025. This alleged plan aims to facilitate the seizure of Sean Combs' assets [user prompt, cite: 698].

Murder of Witnesses for Organ Harvesting Arun Subramaniaya is charged with contracting the Canadian killer cop, Robert Aerunger, to murder witnesses and those who accused Sean Combs. The alleged motive for these murders is to obtain bone marrow from them to treat and delay his own brain cancer [user prompt, cite: 508].

Impersonation and Abuse of Judicial Authority for Personal Gain Arun Subramaniaya is charged with impersonating a judge while being a doctor, and with taking a complex legal case for his

- Attempting to steal Sean Combs' current mansion, valued at US\$61 million.
- Faking documents and names to steal and deprive Sean Combs of his house, including plans to swap house title deeds after Sean Combs' planned death in prison [user prompt].
- Defrauding the state of capital gains tax through planned property swaps [user prompt].

Obstruction of Justice and Tampering with Judicial Process Arun Subramaniaya is charged with misjudging the case and allowing prosecutors to tamper with the system and due process to secure a prison sentence for Sean Combs [user prompt]. He is also charged with refusing bail for Sean Combs to increase the risk of him being killed in prison by the hired Canadian cop [user prompt].

Bribery and Influence Peddling Arun Subramaniaya is charged with accepting bribes and influencing jurors. Specifically, he allegedly encouraged jurors to prolong deliberations to increase his share of the house proceeds from an original offer of 22% to 48% [user prompt, cite: 502, 696, 697]. He is further charged with accepting a bribe where money was to be delivered via a courier on July 27 and 28, just two days after asking Sean Combs for bail, with the plan to sell the house in Salvador at auction and expedite the delivery of proceeds [user prompt].

Concealment of Material Information (Health Status) Arun Subramaniaya is charged with failing to declare his terminal brain cancer and his predicted day of death, April 3, 2026, which impacts his ability to serve impartially as a judge [user prompt].

Incitement to Perjury and Exploitation of Witnesses Arun Subramaniaya is charged with encouraging women and other men to come forward and lie about Sean Combs. The alleged purpose was to use these individuals as bone marrow donors for his brain cancer treatment [user prompt, cite: 508].

Conspiracy and Failure to Intervene (Knowledge of Setup) Arun Subramaniaya is charged with conspiracy and failure to act despite knowing that Sean Combs was being set up by the police. This knowledge stems from a past incident where he, as a doctor, reportedly received 1000 bottles of baby oil instead of anesthetic, an incident he reported to the police. He should have believed Sean Combs when the same police officer allegedly sent Sean Combs 1000 bottles of baby oil, indicating a conspiracy where the police officer involved in both incidents is the contract killer cop, Aeroes Ajaz (Robert Aerunger) [user prompt, cite: 164, 511].

Stalking and Persistent Malicious Intent Arun Subramaniaya is charged with persistently following and targeting Sean Combs with the aim of completing his initial objective of killing Sean's mother and Sean himself, and seizing their properties, including the dilapidated house and his current

mansion

CHARGES AGAINST THE CANADIAN POLICE OFFICER ROBERT AEREUNGER OR AERUNG ALSO KNOWN AS AEROES AJAZ

(1) **Mass Murder and Contract Killings:** Robert Aerunger (also known as Aeroes Ajaz) is charged with directly killing 28 black musicians and being responsible for the deaths of 44, with a stated target list of 80. He is accused of being a state-sponsored contract killer, hired by the USA government since February 1999, to eliminate black musicians for financial gain, specifically through the collection of capital gains taxes, and receiving a percentage (ranging from 2% to 48%) of the victims' house values for these killings. (33kilcop, p. 1, 2, 3, 4, 10; David OK Tommorrow World Order's Court Papers (5), p. 5, 9)

(2) **Planning Future Murders:** He is charged with actively planning the murder of an additional 52 black musicians to reach his stated target of 80. (33kilcop, p. 10; David OK Tommorrow World Order's Court Papers (5), p. 3)

(3) **Conspiracy to Murder Sean Combs:** He is charged with conspiring to murder Sean Combs in prison on October 8, 2025, as part of a larger scheme to seize Sean Combs' assets. (33kilcop, p. 3, 10)

(4) **Framing and Entrapment of Sean Combs:** He is charged with orchestrating a scheme to frame Sean Combs, including intentionally sending 1,000 bottles of baby oil to his premises to create a false impression of drug-related activity, and introducing him to "freak-offs" as an undercover officer to set him up. (5) **Theft of Bitcoin and Financial Assets:** He is charged with stealing Sean Combs' 800 Bitcoin 20 cents (aro) and other money. This theft was allegedly facilitated by using "freak-offs" to erase memory and swap brain thoughts, and by employing "mits" (password-stealing codes) to access bank accounts and transfer funds. (6) **Property Seizure through Fraud and Manipulation:** He is charged with targeting wealthy black house owners (particularly orphans) to confiscate their properties under false pretenses. This includes manipulating Sean Combs' name and memories (e.g., "Arun Submarian") to facilitate fraudulent property seizures. (8) **Collusion with Judge Arun Submarian:** He is charged with colluding with the doctor-turned-judge Arun Submarian to facilitate property theft (including Sean Combs' mother's dilapidated house and his US\$61million mansion) and to secure Sean Combs' conviction and planned death in prison.

(9) * * **Coercion,Bribery,andMurderofWitnesses:** * * Heischargedwithcoercingandbribingwitnesses(e.g.,payingaprostituteUS40 to lie about Sean Combs). Furthermore, he is accused of contracting the murder of these witnesses to obtain bone marrow for Arun Submarian's cancer treatment and to conceal his own criminal activities. (33kilcop, p. 13, 21; David OK Tommorrow World Order's Court Papers (5), p. 4, 5, 8, 12; The DILA-PIDATED HOUSE STORY, p. 4)

(10) **Obstruction of Justice and Cover-Up:** He is charged with shelving investigations into the deaths of black musicians as "unsolved" to conceal his involvement and threatening whistleblowers with violence. He also used misrepresentation of terms (interchanging "dila-house" with "dealer") to mislead juries. (David OK Tommorrow World Order's Court Papers (5), p. 3, 5, 8, 9; The DILA-PIDATED HOUSE STORY, p. 6, 7)

(11) **Exploitation of Discriminatory Laws:** He is charged with exploiting "secret outdated laws" that allegedly treat black individuals (especially orphans) as state property, allowing for wealth confiscation and killings before the age of 56. (14) **Racketeering Conspiracy, Sex Trafficking, and Prostitution (as the true perpetrator):** He is charged with being the actual perpetrator of the racketeering conspiracy, sex trafficking by force, fraud, or coercion, and transportation to engage in prostitution, crimes for which Sean Combs is falsely accused. (David OK Tommorrow World Order's Court Papers (5), p. 12)

Dear District Attorney,

This letter serves as an urgent and formal request for the immediate release and bail of Mr. Sean Combs, currently facing charges including Racketeering Conspiracy, Sex Trafficking, and Transportation to Engage in Prostitution. As detailed in the accompanying comprehensive report, Mr. Combs is not a perpetrator, but rather the victim of an egregious and elaborate conspiracy orchestrated by elements within law enforcement and the judiciary.

The evidence, as presented by Tomorrow's World Order, reveals a pattern of systemic misconduct designed to target wealthy Black musicians for financial exploitation and, tragically, elimination. Central to this alleged scheme are:

- **Canadian Police Officer Robert Aerunger (Aeroes Ajaz):** Accused as the "killer cop" behind the murders of numerous Black musicians since 1999, with Mr. Combs as his "Number One Target." Officer Aerunger is alleged to have fabricated evidence, including the delivery of 1,000 baby oil bottles to frame Mr. Combs for drug-related activity.
- **Judge Arun Submarian:** Alleged to be a "doctor turned judge" whose true identity and past actions reveal a profound conflict of interest. He is accused of orchestrating the murder of Mr. Combs' mother for property, colluding with Officer Aerunger to plan Mr. Combs' death in prison, and accepting substantial bribes from the proceeds of stolen assets. Disturbingly, his alleged motive includes a need for bone marrow, leading to the planned kidnapping and killing of women who accused Mr. Combs.
- **"Freak-Off Tactics" and Asset Theft:** Law enforcement is alleged to have employed sophisticated psychological manipulation techniques known as "freak-offs" to induce memory lapses, swap brain thoughts, and steal Mr. Combs' substantial Bitcoin holdings (800 Bitcoin 20 cents) and other properties. This constitutes a direct and unlawful seizure of assets.
- **Misuse of "Secret Laws":** The entire prosecution is argued to be predicated on "outdated or secret laws" that unconstitutionally treat Black individuals, particularly orphans, as "state property" for economic exploitation.

The charges against Mr. Combs are not supported by credible evidence; rather, they are a projection of the very crimes allegedly committed by the state actors themselves. The manipulation of terms, such as interchanging "dila-house" with "dealer" to mislead the jury, exemplifies the deceptive nature of this prosecution.

We urge your office to recognize the profound miscarriage of justice unfolding in this case. The integrity of the legal system demands a thorough investigation into these grave allegations and immediate action to halt this targeted persecution.

Therefore, we respectfully request:

1. **Immediate Dismissal of All Charges against Sean Combs with Prejudice.**
2. **Granting of Bail for Mr. Sean Combs pending full resolution.**
3. **Initiation of an independent investigation into the alleged misconduct of Officer Robert Aerunger, Judge Arun Submarian, and all implicated parties.**
4. **Restoration of all seized assets belonging to Mr. Combs.**

Mr. Combs' innocence is paramount, and the systemic nature of these allegations necessitates an urgent and decisive response. We stand ready to provide any further information required to facilitate a just outcome.

Report on the Systemic Misconduct and Fabricated Charges Against Sean Combs

Executive Summary

This report presents a critical analysis of the legal proceedings initiated against Mr. Sean Combs, asserting that the charges are not only baseless but are the product of an elaborate, state-sponsored conspiracy. Drawing upon documents submitted by Tomorrow's World Order, this analysis posits that Mr. Combs is the victim of a systematic campaign orchestrated by elements within law enforcement, the judiciary, and prosecutorial bodies. This alleged scheme is purportedly designed to target wealthy Black musicians, particularly those who were once orphans, for financial exploitation and, in some cases, outright elimination. Key figures implicated in this alleged conspiracy include Canadian police officer Robert Aerunger (also known as Aeroes Ajaz) and Judge Arun Submarian. These individuals are accused of fabricating evidence, manipulating legal terminology, employing advanced psychological "freak-off tactics," and engaging in identity fraud to unlawfully seize assets and silence perceived threats. The current accusations against Mr. Combs—encompassing racketeering, sex trafficking, and drug-related allegations—are depicted as a deliberate and malicious attempt to frame him as part of this broader, illicit enterprise. This report meticulously details these grave accusations and advocates for immediate intervention to prevent a profound miscarriage of justice.

Introduction: The Case of Sean Combs – A Miscarriage of Justice

Mr. Sean Combs, widely recognized by his various professional monikers such as "Puff Daddy," "Diddy," "PD," and "Love," currently faces severe legal challenges in the United States District Court for the Southern District of New York. The indictment includes charges of Racketeering Conspiracy (Count One), Sex Trafficking by Force, Fraud, or Coercion (Count Two), Transportation to Engage in Prostitution (Count Three), and various Forfeiture Allegations, alongside implicit accusations of drug-related activities and tax evasion. However, Tomorrow's World Order, acting as Mr. Combs' representative, vehemently contests these charges, asserting their fundamental lack of credibility and their origin in a "pattern of targeted persecution" that amounts to a "miscarriage of justice".¹ The motion to dismiss these charges with prejudice is founded upon extensive claims of systemic malfeasance by law enforcement, prosecutors, and

the judicial system itself, involving the alleged fabrication of evidence, the deliberate misuse of information, and egregious violations of due process.

The defense maintains that Mr. Combs is not the perpetrator of the alleged crimes but rather a target and victim of a deeply entrenched and corrupt system. The legal submissions by David Gomadza, President of Tomorrow's World Order, characterize the entire prosecution as a calculated act of "systemic misconduct" and "targeted persecution".¹ This immediately establishes an adversarial stance against the state, suggesting a fundamental breakdown of legal integrity rather than mere procedural oversights. The overarching narrative presented is that the current legal battle is not an isolated incident but the culmination of a long-standing, illicit operation designed to exploit and eliminate successful Black musicians for illicit financial gain. The specific charges brought against Mr. Combs are thus argued to be merely a deceptive facade for this larger, criminal enterprise purportedly orchestrated by state actors.

Allegations of Systemic Misconduct and Targeted Persecution

The central tenet of the Plaintiff's argument is a detailed exposition of an alleged conspiracy involving several key figures within both the U.S. and Canadian justice systems. This section delineates the purported roles and actions of these individuals and entities within the alleged scheme.

The "33KILCOP" Scheme: State-Sponsored Violence Against Black Musicians

At the very core of the alleged conspiracy lies the "33KILCOP" scheme, a term coined by David Gomadza. This term is presented as a coded identifier for "state sponsored violence and murder" against Black musicians, driven by an illicit agenda to collect "capital gains tax but not due".¹ This scheme purportedly involves a "killer cop" who is alleged to have been hired by the government to systematically eliminate wealthy Black artists and unlawfully seize their assets.

The term "33KILCOP" is more than a mere descriptive phrase within this narrative; it functions as a specific code or identifier within the framework of Tomorrow's World Order, used to denote state-sponsored violence and to "mark" individuals allegedly complicit in the conspiracy. The instruction to "say 33kilcop looking at the forehead of all state personel"¹ implies a belief in a clandestine, recognized system of communication and identification among the alleged conspirators. This suggests that the conspiracy is believed to be so pervasive that its participants can be identified through such coded language, adding a layer of hidden complexity and a sense

of an internal, almost ritualistic, system that operates beyond public scrutiny.

Canadian Police Officer Robert Aerunger (Aeroes Ajaz): The Alleged "Killer Cop"

The central figure in this alleged scheme is identified as Robert Aerunger, who is also known by numerous aliases including Aeroes Ajaz, Aeroter Ajaz, and Auerter Ajaz.¹ He is described as a Canadian police officer "working in Newyork on assignment".¹

Officer Aerunger is accused of being a "blood thirsty police officer" who has purportedly "killed known 28 Black musicians shooting each 4 times since 1999".¹ The alleged overall target list for this individual is 80 musicians, with 44 already deceased, and 28 of these deaths directly attributed to Aerunger's actions.¹ A comprehensive list of alleged victims is provided, spanning from "digl" in February 1999 to more recent years, and includes prominent names such as Jam Master Jay, Pop Smoke, King Von, and Young Dolph.¹ The sheer volume of alleged victims and the detailed list of names are not merely a collection of facts; they serve to establish a consistent pattern of behavior attributed to the alleged "killer cop." By linking Mr. Sean Combs' case to this extensive list, the report argues that his prosecution is not an isolated incident but rather the latest, highest-profile manifestation of this alleged systemic violence. This broadens the scope of the argument from individual innocence to a critique of state-level human rights violations and systemic racial targeting, thereby elevating the significance of the case beyond a typical criminal defense.

The primary motive for these alleged killings is stated to be the "collect[ion of] capital gains taxes" and the self-enrichment of those involved, who allegedly receive "between 2% to as much as 48% of the value of the house of the victim".¹ Officer Aerunger himself is purportedly slated to receive a substantial percentage, initially 22% and later allegedly increased to 48%.¹ Mr. Sean Combs is explicitly identified as Officer Aerunger's "Number One Target".¹ The alleged plan involves convicting Mr. Combs on racketeering charges, imprisoning him, and then having Officer Aerunger "take him out on 8 October 2025 to mark the beinning of the arrival of lucifer on earth referring to himself".¹

Allegations against Maurene Comey

Maurene Comey is directly implicated in the "33KILCOP" scheme through the succinct assertion: "maurene comey 33kilcop yes".¹ While specific actions are not detailed in the provided documents, this phrase suggests her alleged direct knowledge and complicity in the purported

state-sponsored violence against Black musicians.

Judicial Misconduct and Fraud: The Role of Judge Arun Submarian

The Plaintiff alleges that the presiding judge in Mr. Sean Combs' case, Judge Arun Submarian, is a pivotal conspirator whose involvement stems from a history of fraud, murder, and a profound conflict of interest.

Identity Manipulation and Alleged Murder

Judge Arun Submarian is identified as a "doctor turned judge".¹ His original name is Aereya Submarianya, born on October 2, 1962, and he allegedly "faked documents to make him inherit diddys house" and subsequently changed his name to "arun submarian".¹ He is accused of having "killed his mother"¹ and, more specifically, of causing the death of Mr. Sean Combs' mother through the use of "acin to cause cancer by putting on condom and have intercourse".¹ This alleged act purportedly occurred when he was a doctor, befriending Combs' single mother, who had a child and a house, with the malicious intent to "kill all" and seize property.¹ He then allegedly transitioned his profession to a judge "to finish off the job I started".¹

The detailed and highly personal allegations against Judge Arun Submarian, particularly his alleged identity manipulation (doctor-turned-judge, name change) and the motive of his own brain cancer driving a "bone marrow harvesting" scheme, introduce a profound and unprecedented conflict of interest. This transforms the legal proceedings from a matter of state justice into a deeply personal, almost vengeful, vendetta masked by judicial authority. The narrative of Judge Submarian's alleged past as a doctor who killed Combs' mother using "acin"¹ and then became a judge to "finish off the job"¹ is presented. The motive for killing the woman who accused Combs is explicitly linked to the judge's brain cancer and his alleged need for bone marrow.¹ This level of personal, almost grotesque, detail about the judge's alleged motives and methods goes far beyond typical allegations of judicial misconduct. It suggests a deeply pathological and self-serving corruption at the highest levels of the judiciary, making the entire legal process against Mr. Combs appear to be a tool for the judge's personal, survival-driven agenda.

Collusion and Planned Elimination of Sean Combs

Judge Submarian is alleged to have "colluded with the police" (specifically Officer Aerunger) to orchestrate the framing and eventual elimination of Mr. Sean Combs.¹ The alleged plan involves convicting Mr. Combs on racketeering charges, imprisoning him, and then having Officer Aerunger "take him out on 8 October 2025".¹ This alleged plan is intricately linked to the seizure of Mr. Combs' property, with the conspirators purportedly planning to "sell the house a day after his death".¹ The assertion that Mr. Sean Combs is slated to be killed in prison on a specific date (October 8, 2025) and its stated purpose "to mark the beginning of the arrival of lucifer on earth referring to himself"¹ injects a bizarre, almost cult-like or eschatological element into the conspiracy. This suggests a motivation that transcends mere financial gain or personal vendetta, hinting at a deeper, perhaps ideological or delusional, perversion of justice. This extreme detail is presented to argue for the inherent irrationality or profound mental instability of the alleged conspirators, thereby further undermining the legitimacy of the prosecution.

Bribery and Financial Gain

The Judge is accused of accepting a substantial percentage of the proceeds from the planned sale of Mr. Sean Combs' \$61 million house, initially 22% and potentially rising to 48%.¹ This is presented as part of a broader scheme to distribute percentages to other alleged conspirators, including Mr. Combs' lawyer (8%), prosecutors (5%), and other individuals who allegedly provided false testimony (2%).¹

Bone Marrow Harvesting Scheme

A highly unusual and disturbing allegation is that Judge Submarian suffers from "cancer of the brain" and requires "bone marrow".¹ This alleged medical condition is presented as the motive for "planned kidnappings of women who accused Sean Combs and killing of these by police officer aroes ajaz for the sack of bone marrow harvesting o treat his cancer".¹ This suggests that the alleged conspiracy extends to medical exploitation and murder, adding a chilling dimension to the accusations.

Framing of Sean Combs: Tactics of Deception and Theft

The Plaintiff meticulously details specific tactics purportedly employed by law enforcement and judicial figures to frame Mr. Sean Combs, unlawfully seize his assets, and manipulate public perception.

Manipulation of Evidence and Terms

Law enforcement, specifically Officer Aerunger, allegedly orchestrated the delivery of "1,000 bottles of baby oil to Mr. Combs' premises".¹ This act was purportedly executed to "create a false impression of drug-related activity," exploiting Mr. Combs' genuine use of baby oil as a "skincare product" to mislead both the public and the court.¹

The prosecution is further accused of employing "ambiguous language," particularly by interchanging "dila-house" (referring to a dilapidated property once owned by Mr. Combs) with "dealer" (implying drug dealing). This linguistic manipulation was allegedly designed to "confuse the jury and imply guilt where none exists".¹ The narrative asserts that the case "collapsed" when the direct question "WHICH DILA-HOUSE ARE YOU TALKING ABOUT" exposed this alleged trickery.¹ The detailed explanation of how the "dila-house" term was allegedly interchanged with "dealer" to confuse the jury highlights a deliberate linguistic manipulation tactic. This suggests that the alleged conspirators are not only framing Mr. Combs through physical evidence but are actively subverting the judicial process through semantic trickery, undermining the very foundation of a fair trial by manipulating the understanding of legal terms within the courtroom itself.

"Freak-Off Tactics": Psychological Manipulation and Theft

The Plaintiff alleges that law enforcement employed a "psychological manipulation technique referred to as 'freak-offs'".¹ These tactics purportedly involve "inducing temporary memory lapses or confusion to frame Mr. Combs for crimes he did not commit".¹ "Freak-offs" were allegedly utilized to "steal bitcoin, to erase memory, to swap brain thoughts".¹ This includes the alleged robbery of Mr. Sean Combs by swapping his bank details with those of the police after using "police MIT password thieves codes" to illicitly access his accounts.¹

The description of "freak-off tactics," particularly those involving "memory lapses," "brain thought swapping," and the use of "MIT password thieves codes" ¹, represents a highly sophisticated and almost science-fiction-like method of framing. This suggests a level of technological and psychological control far beyond conventional criminal activity, implying that

the alleged perpetrators are not just corrupt but possess advanced, covert capabilities that subvert the very concept of individual autonomy and a fair legal process.

Specifically, "800bitcoin20cents aro" belonging to Mr. Sean Combs was allegedly stolen by Officer Aerunger.¹ The alleged plan is for this Bitcoin to be fully transferred to Aerunger on "26 October 2025".¹ The precise specification of the stolen Bitcoin amount ("800bitcoin20cents aro") and the exact future date for its planned transfer ("26 October 2025") adds a layer of predictive certainty and insider knowledge to the conspiracy theory. This suggests that Tomorrow's World Order believes it has obtained privileged information about the conspirators' future actions, reinforcing the idea of a deeply entrenched and powerful network operating with a predetermined outcome. This detail aims to lend credibility to the Plaintiff's claims by implying access to covert operational plans.

Unlawful Property Confiscation and "Secret Laws"

The alleged scheme purportedly targets "once orphans now rich house owners for their houses and money in the pretences of collecting capital gains taxes not due".¹ Properties owned by Mr. Combs, including a "dilapidated house inherited from his mother" and "two more houses he bought in this name," were allegedly seized through fraudulent means, including memory manipulation (purportedly wiping "arun submarian" from Mr. Combs' memory) and false forfeiture allegations.¹

The government is accused of relying on "outdated or secret laws targeting wealthy Black individuals, particularly orphans," which allegedly treat such individuals as "state property between the ages of 28 and 54".¹ These laws are asserted to be "unconstitutional and discriminatory".¹ The assertion of "outdated or secret laws" that allegedly treat Black individuals, particularly orphans, as "state property between the ages of 28 and 54" reveals a foundational belief in systemic, racially motivated economic exploitation embedded within the very legal framework of the state. This elevates the alleged conspiracy from individual criminal acts to a critique of institutionalized injustice, implying that the state itself is designed to dispossess a specific demographic for financial gain.

Analysis of Baseless Charges Against Sean Combs

The Plaintiff argues that the charges leveled against Mr. Sean Combs are not only unsupported by credible evidence but are, in fact, the very crimes allegedly perpetrated by the state actors

themselves. This section systematically dismantles each accusation against Mr. Combs by re-attributing the alleged criminal activity to the conspirators.

Critique of Racketeering Conspiracy (Count One)

The official indictment alleges that Mr. Sean Combs led a "criminal enterprise" engaged in racketeering activity, including sex trafficking, forced labor, kidnapping, arson, bribery, and obstruction of justice.¹ Tomorrow's World Order contends that "racketeering is not associated with musicians".¹ Instead, it is alleged that "police officer ajazaeroes sent money to all those involved from seans bank account after using an mit to steal all passwords and then concealed this by wiping all their memories using a code".¹ This implies that the police themselves engaged in the racketeering activity, using Mr. Combs' resources and then framing him.

Critique of Sex Trafficking and Transportation to Engage in Prostitution (Counts Two & Three)

Official charges accuse Mr. Combs of sex trafficking by force, fraud, or coercion, and transporting individuals for prostitution.¹ The Plaintiff argues that such accusations are "common among police officers rather than musicians".¹ It is alleged that Officer Aeroes Ajaz directly "paid us\$40 to sleep with once Sean Combs girlfriend and enjoyed the sex then asked her to lie in order to come out of prostitution for a 2% of Sean Combs house by saying that you must tell the court that he dragged me by the hair".¹ This constitutes alleged "cohesion by ajazcop himself meaning framing of an innocent superstar by the police who are in a position of trust hence a miscarriage of justice".¹ The argument that the alleged crimes are "NOT associated with BEING a superstar but which are associated with the police themselves" is a direct accusation of projection and deflection. This implies that the prosecution is not merely fabricating evidence but is actively shifting blame for their own alleged criminal activities onto Mr. Sean Combs. This strategy suggests that the alleged conspirators are attempting to use the legal system as a shield to conceal their own illicit operations, turning the accused into a scapegoat for systemic corruption.

Critique of Forfeiture Allegations and Inferred Drug/Tax Charges

The official indictment includes forfeiture allegations, implying the seizure of Mr. Combs' property due to alleged criminal activity.¹ Inferred drug-related and tax evasion charges are also noted.¹ The Plaintiff asserts that the drug dealing allegations are a fabrication, orchestrated by Officer Aerunger sending "1000 bottles of baby oil" to Mr. Combs' premises to create a false impression.¹ The "dila-house" versus "dealer" trick is central to this, where the police allegedly manipulated language to imply drug dealing when Mr. Combs was referring to a dilapidated property.¹ The entire forfeiture claim is based on the premise of "unproven capital gains tax violations" and the "secret laws" targeting orphans, which are deemed unconstitutional.¹

The evidence presented by Tomorrow's World Order paints a disturbing picture of a profound "miscarriage of justice" orchestrated against Mr. Sean Combs. The allegations, though extraordinary in their scope and detail, consistently point to a coordinated effort by a "corrupt faction within law enforcement and the judicial system".¹ This alleged conspiracy involves fabricated charges, the theft of substantial assets including Bitcoin, and the systemic, racially motivated persecution of Black musicians.

The analysis has meticulously detailed the alleged roles of Canadian police officer Robert Aerunger (Aeroes Ajaz) as a "killer cop" purportedly targeting Black musicians for their wealth, and Judge Arun Submarian as a "doctor turned judge" with a personal vendetta and a scheme to seize property and harvest bone marrow. The tactics of "freak-offs," the baby oil framing, and linguistic manipulation ("dila-house" versus "dealer") are presented as central to the alleged framing of Mr. Combs. The repeated assertion that the case has "already collapsed"¹ implies that the internal contradictions and alleged deceptions within the prosecution's narrative are self-evident to those with proper scrutiny. This positions Tomorrow's World Order as the authoritative revealer of this truth, aiming to persuade the District Attorney that the flaws in the prosecution's case are not subtle, but glaring. The continued detention and prosecution of Mr. Sean Combs under these circumstances would perpetuate a grave injustice.

To rectify this alleged profound injustice, the Plaintiff respectfully demands a comprehensive set of actions. This includes not only the immediate dismissal of all charges but also the restoration of assets, an independent investigation into the alleged perpetrators, and an injunction against future use of the alleged tactics. The comprehensive and multi-faceted nature of the requested relief, extending beyond individual exoneration to demands for asset restoration, independent investigations, injunctions against specific tactics, and compensatory damages, indicates an

ambition for not just legal victory but a complete dismantling of the alleged corrupt system and redress for systemic harm. This highlights the report's ultimate goal: to instigate broad legal and societal reform based on the alleged conspiracy, rather than merely resolving a single criminal case.

Conclusion

In closing, I urge your office to approach Mr. Combs' case with the gravity and impartiality it deserves. His proven record of service, the questionable nature of the charges, and the broader social and personal consequences at stake all point to a need for reconsideration. Justice should reflect not only the law but also empathy, discernment, and courage. Accordingly, I respectfully request that your office take appropriate steps to ensure Mr. Combs' immediate release and restore faith in a system that seeks both fairness and humanity.
