I. INTRODUCTION

Sean Combs, a prominent musician and entrepreneur, is wrongfully detained based on fabricated evidence and prosecutorial misconduct orchestrated by Assistant U.S. Attorney Maurene Comey, in collaboration with Canadian police officer Robert Aerunger (alias Aeroes Ajaz) and others. The prosecution's case relies on a video falsely attributed to Mr. Combs, which instead depicts Daunte Asey, (identified by electromagnetic wave identifier unique to each individual see background material) the lookalike with a documented history of violence. Furthermore, credible evidence suggests a conspiracy to frame Mr. Combs, involving bribery, evidence tampering, and a pattern of targeting Black musicians for financial gain. Most alarmingly, Mr. Combs' life is in imminent danger, with reports indicating a planned assassination on October 2, 2025, disguised as a suicide. This Court must act swiftly to prevent a miscarriage of justice and protect Mr. Combs' life.

II. LEGAL STANDARD

Under 18 U.S.C. § 3143(b), a defendant may be released pending appeal if they demonstrate: (1) they are not a flight risk or danger to the community, and (2) the appeal raises substantial questions of law or fact likely to result in reversal or a new trial. Additionally, under Fed. R. Crim. P. 33, a court may grant a new trial if newly discovered evidence demonstrates a violation of due process or prosecutorial misconduct. Finally, under the Due Process Clause of the Fifth Amendment, convictions based on fabricated evidence or prosecutorial misconduct must be vacated. See *Brady v. Maryland*, 373 U.S. 83 (1963); *Napue v. Illinois*, 360 U.S. 264 (1959).

Newly Discovered Evidence of Mistaken Identity Undermines the Conviction

The prosecution's case against Mr. Combs hinges on a video purportedly showing him assaulting Cassandra Ventura.

However, newly discovered evidence reveals that the individual in the video is not Mr. Combs but Daunte Asey with a documented history of violence and a physical resemblance to Mr. Combs. Who people call Sean Combs because of the resemblance born on 26 May 1981 and the woman is Cassandra Ventura but another one from Puerto Rico (born May 10, 2001 see electromagnetic wave identifier in background notes) Key identifiers distinguish Cassandra Ventura the Puerto Rican from Cassandra Ventura Elizabeth who knew Diddy, including a cancerous lump on the Puerto Rican's left chin. Furthermore, forensic analysis of the video, supported by expert testimony, indicates it was manipulated to merge images of Asey and Combs, creating a false impression of Combs' involvement. This constitutes a deliberate fabrication of evidence, violating Mr. Combs' due process rights under *Brady* and

Napue. Additionally, Daunte Asey, the true perpetrator, was killed eight days ago at hell reception, allegedly by officer Robert Aerunger, to silence him and prevent exposure of the prosecution's scheme. This act further corroborates the claim that Asey, not Combs, was the individual in the video. The prosecution's failure to disclose Asey's identity and death constitutes a Brady violation, as it withheld exculpatory evidence critical to Mr. Combs' defense.

B. Prosecutorial Misconduct and Judicial Bias Taint the

Proceedings Criminal investigation into the judge Maurene comey() and Robert Aerunger.mp3

The prosecution, led by Assistant U.S. Attorney Maurene Comey, has engaged in egregious misconduct, including:

Fabrication of Evidence: The prosecution knowingly presented a manipulated video to the jury, misrepresenting Daunte Asey as Sean Combs. This act of evidence tampering violates due process and undermines the integrity of the trial.

Conspiracy to Frame Mr. Combs:

Evidence suggests a

broader conspiracy involving Ms. Comey, officer Robert Aerunger, and Judge Arun Subramanian (alias Aereya Subramaniya) to target Black musicians for financial gain. Judicial Bias

Judge Subramanian, who presided over Mr. Combs' case, is implicated as posed to Receive 48% instead of 22% but giving incorrect instruction in deliberately that made them reach a deadlock as a way to protest so that they increase his share from 22% to 48% and the others posed to get 8% instead of the usual 2% all to be delivered on 27 and 28 July 2025 at 3pm by a courier all money from the proceeds of Sean Combs House if they are not stopped the house was planned to be sold at auction in Salvador by taking once Sean Combs name Arun subramania in anticipation that the house is in this name as his original name is aereya subramania born on 2 October 1962 but changed to 8 October 1968 then to 1979 who mistakenly received 1,000 bottles of baby oil as a mistake, allegedly in lieu of anesthetic, to make him ready in exchange for favorable rulings. **This conflict of interest, combined with his alleged**

These actions collectively violate Mr. Combs' right to a fair trial under the Sixth Amendment and warrant dismissal of all charges.

C. Imminent Threat to Mr. Combs' Life Necessitates Immediate Release Credible intelligence indicates that Mr. Combs faces an imminent threat to his life, with a planned assassination scheduled for October 2, 2025, orchestrated by Robert Aerunger and disguised as a suicide.

Aerunger's alleged history of killing Black musicians, including eight deaths in the past week, underscores the urgency of this threat. **The Court has a duty to protect Mr. Combs' life under the Eighth Amendment's** prohibition on cruel and unusual punishment. Immediate release is the only means to ensure his safety, as continued detention places him at the mercy of those orchestrating this conspiracy.

D. The Charges Are Unsupported by Credible Evidence

The charges against Mr. Combs, including two counts of transportation to engage in prostitution, rely on the same fabricated evidence and tainted testimony. The alleged "freak offs" cited by the prosecution are a pretext, with no credible evidence linking Mr. Combs to criminal activity. Instead, the evidence points to a setup by Aerunger and Comey, who manipulated events to frame Mr. Combs while pursuing their own illicit motives. Dismissal of all charges is warranted under Fed. R. Crim. P. 29 due to insufficient evidence.

. Investigation of Prosecutorial and Judicial Misconduct Is Warranted The allegations of misconduct extend beyond this case, implicating a systemic pattern of targeting Black musicians for financial gain and personal vendettas.

Specific charges requiring investigation include:

Maurene Comey: Alleged orchestration of a conspiracy to frame Mr. Combs, including evidence tampering and collaboration with Robert Aerunger to kill witnesses and defendants.

Robert Aerunger (alias Aeroes Ajaz): Alleged murder of Daunte Asey and seven others in the past week, targeting Black individuals for financial gain and to cover up his role in framing Mr. Combs.**Judge Arun Subramanian (alias Aereya Subramaniya):**

Alleged acceptance of bribes and conflict of interest, including prior misconduct in Memphis involving the targeting of single parents with cancer. These individuals must be investigated for violations of 18 U.S.C. § 242 (deprivation of rights under color of law), 18 U.S.C. § 201 (bribery), and 18 U.S.C. § 111 (assault or murder of federal witnesses)

.IV. REQUESTED RELIEF

Based on the foregoing, Mr. Combs respectfully requests:

Immediate Release: Unconditional release from custody to-penalty, 4px, 4px">custody, pending appeal, to protect his life and ensure due process.

Dismissal of All Charges: Dismissal of all charges, including the two counts of transportation to engage in prostitution, **due to fabricated evidence and prosecutorial misconduct.**

Investigation of Misconduct: Immediate investigation into the actions of Maurene Comey, Robert Aerunger, and Judge Arun Subramanian for evidence tampering, bribery, and murder. **Protective Measures:**

Court-ordered protection for Mr. Combs to prevent the planned assassination on October 2, 2025.V. **CONCLUSION**

The prosecution's case against Sean Combs is a travesty of justice, built on fabricated evidence, prosecutorial misconduct, and a conspiracy to target Black musicians. The imminent threat to Mr. Combs' life demands immediate action. This Court must release Mr. Combs, dismiss all charges, and investigate the systemic corruption that has led to this wrongful conviction. PART I

INTRODUCTION

The Plaintiff, Sean Combs, through his representative, Tomorrow's World Order, respectfully moves this Honorable Court to dismiss with prejudice all charges filed against him in the above-captioned matter. This motion is based on allegations of systemic misconduct by law enforcement, prosecutors, and the judicial system, including but not limited to fabricated charges, misuse of evidence, and violations of due process. GROUND FOR DISMISSAL

The Plaintiff submits the following grounds for the immediate dismissal of all charges:

Lack of Credible Evidence and Fabrication of Charges

The charges against Mr. Combs are unsupported by credible evidence and appear to be the result of deliberate fabrication by law enforcement. Specifically, the Plaintiff alleges that the police, led by an officer identified as "Aeroes Ajaz," have engaged in a pattern of misconduct, including: Manipulation of Evidence: The delivery of 1,000 bottles of baby oil to Mr. Combs' premises was orchestrated by law enforcement to create a false impression of drug-related activity, exploiting Mr. Combs' use of baby oil as a skincare product to mislead the public and the court.

Systemic Targeting of Mr. Combs and Other Black Musicians

Historical Pattern of Misconduct: The document cites the alleged killings of 28 Black musicians since 1999, purportedly orchestrated by Officer Aeroes Ajaz, with the intent to seize their wealth, including Bitcoin and real property.

Due Process Violations

The Plaintiff alleges multiple violations of Mr. Combs' constitutional rights, including:

Framing and Entrapment: The Plaintiff claims that Officer Aeroes Ajaz and other law enforcement officials orchestrated a scheme to frame Mr. Combs by introducing him to "freak-offs," manipulating financial transactions, and fabricating evidence, such as swapping bank details to create the appearance of illicit activity.

Property Confiscation: Properties owned by Mr. Combs, including a dilapidated house inherited from his mother and two others purchased under the alias Arun Submarian, were allegedly seized through fraudulent means, including memory manipulation and false forfeiture allegations.

Misuse of Secret Laws and Practices

The Plaintiff alleges that the government has relied on outdated or secret laws targeting wealthy Black individuals, particularly orphans, to justify asset seizures and criminal charges. These laws, which allegedly treat such individuals as state property between the ages of 28 and 54, are unconstitutional and discriminatory.

COUNTER-ALLEGATIONS AGAINST LAW ENFORCEMENT AND THE GOVERNMENT

The Plaintiff asserts that the true perpetrators of criminal activity in this case are members of law enforcement, prosecutors, and the judicial system. Specific counter-allegations include:

Murder and Conspiracy to Murder

Officer Aeroes Ajaz is accused of orchestrating or directly committing the murders of 28 Black musicians since 1999, with plans to kill an additional 52, totaling 80 targeted individuals.

The government is accused of hiring Officer Ajaz to carry out these contract killings, motivated by the desire to seize wealth and property.

Theft and Fraud

Law enforcement allegedly stole Bitcoin and real property from Mr. Combs and other Black musicians through sophisticated schemes, including the use of "freak-offs" to manipulate memories and financial records.

The Plaintiff claims that police used MIT (password-stealing) codes to access Mr. Combs' bank accounts, transfer funds to third parties, and erase evidence of these transactions.

Cover-Up and Intimidation

The Plaintiff alleges that law enforcement has shelved investigations into the deaths of Black musicians as "unsolved" to conceal their own involvement.

Threats of violence, including the deployment of "250 gunmen," were allegedly used to intimidate potential whistleblowers.

Judicial and Prosecutorial Misconduct

Investigation of Law Enforcement Misconduct: Direct an independent investigation into the actions of Officer Aeroes Ajaz, the presiding judge, and the prosecuting attorneys for their alleged roles in framing Mr. Combs and targeting other Black musicians.

Injunction Against Further Targeting: Issue an injunction prohibiting law enforcement from using "freak-off" tactics, secret laws, or other unconstitutional methods against Mr. Combs or similarly situated individuals.

Compensation for Damages: Award compensatory damages for the emotional, financial, and reputational harm caused by the government's actions.

We don't die and we know all what goes around.
