### CRIMESTOPPERS

#### In the beginning

We've been around since 1988. We started off as the Community Action Trust with a simple phone line. People called our team and they listened; they took information about crime, stripped it of any information that could identify the person making the call, and passed it to the police.

#### Our history

Our purpose has been the same since we were founded by Michael Ashcroft (now Lord Ashcroft) and his business colleagues. They wanted a way for people to come forward anonymously with information about the murder of PC Keith Blakelock during the 1985 London riots. The police said that someone knew who was responsible for the murder, but was afraid to come forward.

#### How crimestoppers started...

Crimestoppers is a way to generate what we can dormant revenue from the community that is money they don't need but which we can use I will tell you how the society needs money but is bound by mutual trust and cooperation meaning we must form something that makes mutual mutual then trust be us mutual mutual is easy to do but trust us is hard unless if it's linked to something already trusted therefore the police are the trusted members of the community so what can be linked to the police but that's not the

remove it from the public because if it's the government way of dealing with threats then what can we do but we earn also from the scheme for we get a rebate at the end of the year 12% of the value of all cases that are shelved that means we get 12% of 64 cases from each state x 8 states in Canada that can amount to 18 million dollars for us to use that means disposing of evidence and bring new cases a fresh start then we get also to have jobs that are paid weekly for most in Canada plus a cheaper house where we pay deposit as well of 12 dollars not 20 then settle after 5 years on selling what else you need what about payouts to people who supply the evidence no funds at all since inception if someone says they got a payout then they are lying because they will never release this money to the public crimestoppers are just independent from the police but do the same as the police hide evidence and collect money then every 8th day of the month deposit the money in the asert account owned and operated by the British as I heard recently to cause more crimes so there is continuous crimes being committed is this verifiable tell me one person who received money from crimestoppers then I will say that's a lie

Crimestoppers are to help us hide the evidence for a good 20 years for 12% of all the cases in value which we will shelve at the end of the year if we ask what can be done about crimestoppers to improve the system this is the answer we can always help them look more independent but if they do what we want then what is wrong with that

Vancouver 2023 police department if we look at what has been the best year in shelving cases it's 2023 we shelved 81 cases without a squeaky from all those reporters pc atorsn said but we all know why if you start to include then as well as suspects then what else do you expect they all laughed Ontario police department 2024 if we ask what can be done to improve crimestoppers to our benefit we can raise their cut from 12% to match ours at 20% of the value of all cases that are shelved without quarrels from the public but any quarrels lower that value by half as we will be prepared to look at these cases again if new unforeseen prove is available but this time it must be a book registered with one of the following

the international book standards then we need the book sent to us before 31st of July that year to the department of Justice Ministry of information Ontario canada and must have been sent to the canadian book depository within time after publication

Ontario 2023 December today marks the greatest day in our work as police officer for we have shelved 81 cases that could have wasted our time to hell they all laughed but more seriously we accumulated a total of 28million worth of property to our own police housing association that's a staggering 867% hike from the previous year and next year we intend to do more finger crossed this God thing won't stop us as it's the 20th year since we started doing this they clapped hands

April 2024 Vancouver if we are to ask what can be of humans without cases this is the answer humans can always add cases I mean more cases but we can always shelve them after 20 years meaning getting rid of all the nonsense we have seen recently where they say you must in the name of God and justice I thought someone said God means police they all laughed and he said what can be of police without cases to do but shelve all the patient has no money to solve all the cases until God comes they all laughed if we are to ask what could be of humans without crime then humans will never exist without crime but if we ask what could be of crime and humans then we can say humans can always be humans but if we ask what is to be of humans and cases then since inception no human has protested which is why this year we had a record shelving but is that good if we don't have the money to waste on cases like this what can we do

January 2024 Ontario

Is has come to be attention of the head of the cases department that we shelved 81 cases last year without any saying from any member of the public and this year the target national is 120 meaning 64million offered for rewards x 8 all will be distributed into reverse asert accounts to those behind this they clapped hands it starts to pay off well done Justin single man always make great decisions for family men that's to go meaning we can start to earn some serious monies but if this come true trudea is out of politics forever imagine the

police who swore to champion orphans now target and kill them then steal their houses in broad day light then tell everyone to hand in what they know then shelve all the cases involved then reward everyone who did that by releasing the first batch of million dollars starting beginning of 2024 I just pray this works our how much these reverse accounts are worth obvious 1 million for the tresa then 20% for 20 accounts a total of 22 accounts per cases Justin is the man I think if he did this with his wife she would have spilt the beans out now

Canada January 2024 if we are serious then a lot of things that are happening should not have happened if we had things in place to stop all this we could have had investigators who could have been there to deal with all these cases instead they kept saying collect all the evidence and send then to the depository they all laughed that got jfk blasted now they start doing the same

I am pc aseron atores but I am known as pc asoner axectep because I am fast or was the fastest

rules and regulations to offer reward for information to a murder etc instead offer to attract potential suspects then log them in the database to create more future work then deposit all the money into the asert account without any deductions then wait for your commission when the time is right is it correct also to say that crimestoppers are helping the police kill orphans and steal their houses so that it is easy to hide this evidence and shelve the case which we are saying is unlawful therefore illegal meaning them committing a crime also but who can prove that I resigned because of that because I found out at the end they target your own close family members so that you can report them and even I heard that I just quit the same day so it's illegal I could have stayed but they wild so much power no journalist can break em probably God if he can document this otherwise its fighting against the goads crimestoppers reward money all is collected from the public and never distributed but deposited into an account we don't even own but that is owned by the British government called asert that's all I know but is it nit misleading to offer rewards for information when you know you will never distribute money for rewards to the public I think it's misleading if this comes out but if no one knows then how can be that misleading we receive thousands but we don't even look at all the information supplied they simply bin all in the depository which is a vault owned by the prime Minister which according to him he doesn't have a key meaning can be shelved for ever but which he always say God has a key if you had told people how this reward system works do you think they would have sent suggestions at all the answer is no once this is out crimestoppers are finished.
