

CELEBRATE ORILLIA INC.

VENDOR CATEGORIES AND FEES

Celebrate Orillia Inc. offers a few vendor categories for the Canada Day marketplace at Couchiching Beach Park. Vendors must apply under the appropriate category and size, as described on the application form.

All vendors must complete the online Vendor Application form. Applications will be reviewed and approved at the discretion of Celebrate Orillia Inc.

Fees are included in Schedule 1 attached to this document.

MARKET VENDORS

Any vendor that will be selling wares will be considered a Market Vendor. These products include, but are not limited to:

- Sunglasses
- Artwork
- Jewelry
- Clothing and accessories
- Promotional materials
- Consumer products
- Small scale baking/artisan goods

These vendors are required to provide:

- A Certificate of Insurance, with a minimum of \$2,000,000 liability coverage naming Celebrate Orillia Inc., and the City of Orillia as the additional insured.
- A signed Celebrate Orillia Participation waiver

FOOD VENDORS

Food vendors include any business that is preparing, selling or serving food or beverages, excluding what is listed as a Market Vendor item. Food vendors MUST provide:

- A Special Events Food Vendor permit, issued by the Simcoe Muskoka District Health Unit (their website has the application)
- A Certificate Of Insurance, with a minimum of \$2,000,000 liability coverage naming Celebrate Orillia Inc., and the City of Orillia as the additional insured.
- A signed Celebrate Orillia Participation waiver

CHARITY GROUP

Generally, a Charitable Organization, or Not For Profit group. All groups must register using the standard form, selecting Charity type, and fee (\$0), and will be reviewed for compliance before being accepted.

Charity groups must provide:

- A Certificate of Insurance, with a minimum of \$2,000,000 liability coverage naming Celebrate Orillia Inc., and the City of Orillia as the additional insured.
- A signed Celebrate Orillia Participation waiver

HOW TO APPLY

Celebrate Orillia will implement a Google Form type of on-line application. All participants must register on line using the proper form and selections, and acknowledge that they have read and accepted the rules of vendoring

Payment is due once your application is acknowledged. Payment types will include on line, etransfer (preferred), or cheque payable to Celebrate Orillia, the address to be delivered to, will be on the website as it may change yearly.

Upon request, the vendor must supply 3 photos, or a video, of their display. This will help in managing spaces and layout.

Each vendor must read and acknowledge the Celebrate Orillia Rules and Regulations for Vendors- a link to this will be provided in the application form. Vendors will be challenged on the application form that these rules are accepted.

Vendor spaces are limited and will be assigned at the discretion of Celebrate Orillia Inc.

Food Vendor

10'x10', or cart	\$300
20'x10', or trailer	\$400
