Ketone Partners Receives Approval for Speculative Truck Terminal and Maintenance Facility in Joliet

Ketone Partners has received approvals from the City of Joliet to construct a truck terminal and maintenance facility at 3150 Channahon Road in Joliet, where the company plans to break ground on a speculative industrial project.

Ketone acquired the 262-acre site in 2016 and has been actively developing the project which is now home to a 1.3-million square-foot Target Distribution Center, Touchpoint Logistics, and the new corporate headquarters for GP Transco. In addition to the completed facilities, two projects are currently under construction including a 15.5-acre project for a national client and a marine terminal on the Des Plaines River. Located adjacent to the planned Houbolt Road extension and Des Plaines River Bridge providing direct access to the Union Pacific and BNSF Intermodals, the project offers direct access to Interstate 80 via Houbolt Road and Interstate 55 via Route 6.

"The City of Joliet has been a great partner with Ketone and has helped to make our project a success. They understand that, in order to attract and retain quality transportation companies, these types of developments need to be shovel-ready with the necessary entitlements in place," said Jennifer Wagner, Vice President of Development Services at Ketone Partners.

Ketone plans to break ground in the Spring of 2021 on its new project that is planned to consist of an 87,000 square-foot industrial building with up to 800 trailer parking stalls.

"The real estate markets have changed significantly over the past several months, but we are confident this project caters to emerging trends in logistics and will meet the needs of the logistics and transportation industry," said Kyle Schuhmacher, President of Ketone Partners.
