

Pooches & Pours Vendor Agreement



REGISTRATION

- 1. A booth fee of \$25 or \$45 (depending on size) is required from each vendor and must be paid at the time a signed contract is forwarded to Traveler's Cellar Winery. Payment of booth fees must be made out to BGWC Humane Society and mailed to Traveler's Cellar Winery. **Deadline for registration is April 15th, 2023**
- 2. Each vendor is required to bring their own tables, chairs, tents, and any other items needed. Electricity is not provided.

CANCELLATIONS

3. Full refunds and/or credits of all monies will be made if weather cancels the event or if postponed to a later date.

PARKING

4. Vendors may pull up to their designated booth spot to unload their items. After this point, vehicles must be promptly moved to the designated vendor parking area located on the aerial map you will be supplied with.

SET-UP AND PARTICIPATION

- 5. Vendors must always have a representative in their booth and agree to keep the area within their booth free of debris and obstructions that might result in injury to the public.
- 6. Vendors or a representative are expected to be in their booth and set up **30 minutes prior** to 11am.
- 7. **No early packing or event exit will be permitted**. Vendors are expected to display their booths for the full duration of the event and no packing or leaving before 3pm.
- 8. Traveler's Cellar Winery reserves the right to adjust booth placement if unforeseen circumstances arise.

GENERAL

- 9. Vendors must agree not to hold Travelers Cellar Winery, or the Bowling Green Warren County Humane Society liable for the loss, damage or theft of goods, personal property or for the injury to persons or property within the area of the booth assigned to them.
- 10. Failure to follow the guidelines will result in forfeiture of future contracts.
