#### **Pinehirst Bursary Policy 2022-23**

The purpose of this Bursary Fund is to support students to meet the costs of continuing in full-time education such as for transport, books, equipment, trips and other course-related costs; it may also be used towards the costs of attending university interviews and open days.

#### There are two types of Bursaries that you may be eligible to apply for:

#### 1. Vulnerable Bursary (16-18):

# You can apply for this if you are:

- In Care
- Care Leaver
- Receiving Income Support or Universal Credit because you are financially supporting yourself or
  financially supporting yourself and someone who is dependent on you and living with you, such as a
  child or partner.
- Receiving Disability Living Allowance or Personal Independence Payments in your own name, as well as Employment and Support Allowance or Universal Credit.

#### How much will you get paid if you are eligible?

If you are eligible you could get up to £40 per week and £1,200 if you study full time for a minimum of 30 weeks. If your course is less than 30 weeks, you will get less. **Note:** You will only receive the amount you need to participate, we will not automatically award the full £1,200 if you do not need that level of support.

## You will need to provide proof that you are eligible. This is either:

- A letter from your local authority showing you are in care or a care leaver.
- A letter from the Department of Work and Pensions showing the benefits you get (Benefits must be in your own name to get a Vulnerable Bursary).

#### 2.Discretionary Bursary (16-18):

#### You can apply for this if you are:

- Earnings up to £30,000 that come from any one of the following:
  - -Employment salary
  - -Self-Employment earnings
  - -Contribution based Jobseekers Allowance
  - -Contribution based ESA
  - -Pension Income
- Aged 19 or over and have an Education, Health and Care Plan (EHCP)
- Income Support Letter (Most recent entitlement letter from DWP, ideally dated within the last 3 months).
- Income-based Jobseekers Allowance (Most recent entitlement letter from DWP, ideally dated within the last 3 months).
- Income-related Employment and Support Allowance (ESA). (Most recent entitlement letter from DWP.)
- Support under part VI of the Immigration and Asylum Act 1999
- Child Tax Credit (provided they are not entitled to Working Tax Credit) and have an annual gross
  income of no more than £16,190. (Child Tax Credit Award Notice marked "2022/23". Must be for full year and not
  partial awards (FULL AWARD NOTICE) OR Child Tax Credit Review Letter.)
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for WTC (Letter from Tax Credits stating Working Tax Credit has ended and payments are for a 4-week run-on period)
- Universal Credit with net earnings not exceeding the equivalent of £7,400 pa (Most recent UC award notice, dated within the last 3 months)

# How much will you get paid if you are eligible?

If you are eligible you could get up to £40 per week to help cover transport and food costs.
