The applicant agrees to release and discharge the EBA, its agents and employees and the owner of the property from any and all claims and/or liability arising and agrees that the same are not liable and are exempt from lawsuits for injuries or Covid-19 virus or any virus or illness resulting from competing during any EBA sanctioned event. Applicant knows and agrees that by his/her application on this form he/she completely releases the EBA and its directors, officers, representatives, employees, and agents from any liability, including negligence. Applicant voluntarily chooses to participate in EBA sanctioned events, and freely and willingly consents to it. Applicant further acknowledges that he/she has no absolute property or other right to participate in EBA events. Applicants agree to follow and be bound by the rules, regulations, and guidelines of the EBA as amended from time to time. Applicant agrees that his/her sole and exclusive remedy for any disputes is appeal to the EBA appeals board pursuant to EBA appeal procedures contained in EBA Rules Book and agrees that all decisions of the appeals committee are final and conclusive.
