As used herein (unless substantially rewarded) the following shall apply:

- C. Whenever an ellipsis (...) appears in the text this indicates that this portion of the present text remains intact to the point where the next typewritten material appears.

1. Article XI of the Declaration is amended as follows:

**PROVISIONS RELATING TO SALE OR RENTAL OR OTHER ALIENATION
OR MORTGAGING OF CONDOMINIUM UNITS.**

A. SALE OR RENTAL OF UNITS – Association to Have First Right of Refusal

Provided, however, no unit may be rented or leased for a twelve (12) month period following the closing date of the sale of that unit. Any renting or leasing of a unit after said twelve (12) month period shall be restricted as further provided in this Declaration.

The provisions of this Amendment shall not apply to leases already reviewed and approved by the Association or to already approved purchasers of units after the effective date of this amendment as provided in Section 718.110(13) Florida Statutes 2005.
