## 2700 Bulls-eye Pistol Match

### 2024 May Open

Anticipated competitors - 32

**Date:** May 10th and 11th

**Location:** 26 Amasa Road, Greenville, Pa. 16125. Approximately 3 miles north on Route 18 from Greenville, Pa.

**Sponsored By:** White Oaks Shooting Club Inc.

**Eligibility:** Competition is open to all; NRA membership is not required.

**Classes & Categories:** NRA system will be used. If fewer than four (4) entries in a class, competitors will be moved into the next higher class.

**Rules:** All current NRA Conventional Pistol rules will be used.

**Classification:** The NRA classification system will be used in all matches. Individuals who have not been classified will fire in the Master Class, Rule 19.6 (Assigned Classification). Temporary score scorebooks may be used to establish a classification.

**Facilities:** The range is equipped with 16 electronically controlled targets and the firing line is covered.

**Squadding:** Squadding will be on a first come first serve basis, with preference given to shooters who intend to shoot the complete 2700 course of fire. The 2700 aggregate will be fired in one day. There will be one relay on Friday, June 10th and one relay on Saturday, June 11th.

**Advanced Entries:** **Advance entries are requested:** Your advanced registration will assure the competitor of his/her preference and help to make the registration process smoother. You will be notified if your preferred relay is filled.

**Challenges:** A \$2.00 challenge fee will be charged. See NRA Rule 16.1 for procedures to be used.

**Match Conditions:** Scoring will be done down range by the competitors using the pass right, score left procedure. Competitors will be responsible for repairing their targets. The competitor and scorer will sign all scorecards. Only range personnel are authorized to use scoring plugs. All cell phones and pagers must be turned off on the firing line.

**Post Entries:** Will be accepted up to the range capacity.

**Awards:** Awards will be in cash. There will be an OPEN WINNER, in addition to class awards in each match. The OPEN WINNER is not eligible for class awards. Classes will be combined upward if there are less than four (4) competitors in a class. If there are fewer High Masters and Masters (if combined) they will compete for the open award only. There must be at least four (4) competitors in a class to qualify for an award.

**Entries Close:** Individual match entries will close one-half hour prior to the start of the relay.
