



Client Agreement Form (Effective August 9, 2026)

Beautiful Souls Vibrational Studio provides health and wellness benefits to help relax and balance the body, mind, emotions, and spirit. A person's aura is composed of layers of energy, starting with the inner layer connected to the physical body, followed by emotional, mental, and spiritual layers flowing around the body. The gentle, therapeutic, and holistic approach in the aura is based on training and certification in Usui/Holy Fire® III Reiki and vibration and sound healing modalities. Distance Vibrational Healing Sessions are administered by an efficient and experienced practitioner who incorporates techniques and tools, including intention, tuning forks, crystals, sound, breathwork, guided meditations, and/or affirmations. Sessions offered to clients promote relaxation, reduce stress and tension, boost energy and flow, restore balance and harmony, and enhance the body's natural ability to heal itself. Long term imbalances in the body may require multiple sessions in order to facilitate the level of relaxation needed by the body to heal itself.

- The client is eighteen (18) years of age or older and provides consent to a Distance Vibrational Healing Session.
- To prepare for a session, the client is advised to hydrate, remove jewelry and watches, silence phones or devices, and choose a quiet, comfortable space with no distractions.
- The Initial Session is conducted on camera via a Zoom video call, followed by phone. All other sessions are conducted by phone.
- If the client has a) electrical or metal implants, such as pacemaker, stents, dental implants, orthopedic implants, etc., b) herniated discs, or c) disc injuries, the client agrees to disclose this information and its location in the body at the beginning of the session so that the practitioner can exercise caution in that area. If the client forgets to do so, the client understands that there shall be no liability on the practitioner's part or Beautiful Souls Vibrational Studio.

Payment, Reschedule, Lateness, No-Show, and Cancellation Policies:

Payment Policy: Beautiful Souls Vibrational Studio requires full payment at the time of scheduling, prior to a Distance Vibrational Healing Session. This full payment price includes non-refundable credit card processing fees.

Reschedule Policy: Beautiful Souls Vibrational Studio provides an online scheduler that allows clients the ability to reschedule a session at any time, except within 24 hours prior to the start time. Lateness Policy: Beautiful Souls Vibrational Studio schedules structured time blocks for sessions. Sessions are conducted at the scheduled start time via a virtual link or phone call initiated by the practitioner. If the client does not connect to the virtual link or answer the phone at the scheduled start time but they do within the 15-minute grace period, then they are considered late but will not forfeit their entire session time block. The session will still end on time. Late arrivals are not eligible for a full or partial refund.

No-Show Policy: Beautiful Souls Vibrational Studio schedules structured time blocks for sessions. Sessions are conducted at the scheduled start time via a virtual link or phone call initiated by the practitioner. If the client does not connect to the virtual link or answer the phone at the scheduled start time or within the 15-minute grace period, then they are considered a no-show and forfeit their entire session time block. No-shows are not eligible for a full or partial refund.
