- Requirements:** Exhibitor must be a member of ArtWorks, Inc. Non-members may join online at www.artworksbg.org and membership will be good through October 31, 2024.
- Entry Deadline:** Tuesday, November 28, 2023, 11:59 p.m.
- Entry Drop Off:** Thursday, November 30, 2023. Drop off art between 3:00-4:30 p.m.
- Exhibition Dates:** Friday, December 1, 2023 - Thursday, January 11, 2024, Church hours. Opening reception during the Gallery Hop, Friday, December 1, 5-8 p.m.
- Pick Up Date:** Thursday, January 11, 2024. Pick up between 3:00-4:30 p.m. Art must be picked up on this date. There is no storage for leftover art, so send a friend to pick up your art, if you cannot make this time/date.
- Details:** Only original 2D and 3D **ready-to-hang** artwork in any medium will be eligible. **All artwork must be wired. NO exceptions.** Maximum two pieces per artist. Your artwork may be recent or something you created in the past. If your art has been in any other exhibition, that's okay, too. Please only submit artwork that is appropriate for a family setting.

- 4) The title(s) of your piece(s)
- 5) Medium(s) you used

OR, you can make it easy on yourself and enter online by filling in the entry form and hitting SUBMIT.

When you deliver your art on Thursday, November 30, 3:00-4:30 pm., please make sure you have attached your business card or a 3x5 index card to the back of each piece of artwork and include your name, title and price of your art.

The Presbyterian Church is graciously hosting this exhibition and will publicize the event. There is **no entry fee** to exhibit your work, and if your art sells there is **no commission fee!** All sales are made between the buyer and the artist.
