# Link or Register UID with Participant Details

The Aim is to enroll only those who give consent. The consent form is to be signed and uploaded on the google form. Then random ID generation is code-based and combines patient's name, mobile number and a random number combination.

# Paste the UID at the respective section

Enter the Alphanumeric random Unique ID generated by the website. \*

The id is generated through the website by an authorized person only. The alphanumeric random id is the unique id of the patient. The id once generated will not be identical with the same given input of the same participant. Therefore, This ID should be written on a chit of paper and entered into this section for registration. After the unique id is generated participant will be enrolled with the unique id only.

## Eligibility for Cotinine Test

- ▶ Inclusion and Exclusion Criteria except the Cotinine test have been documented as a quiz having 12 full marks. A participant qualifies for the Cotinine Test if he/ she scores 12/12.
- If the score is 12/12 and Cotinine Test is 'positive' then he/ she is enrolled into the trial as a participant.
- Until then the participants are screened not enrolled.
- The next step is to document this enrollement.

Enrolment of the participants is as per UID and not by name. It is done by a researcher who is not aware of the name and other details of the patient (Blinding).

The intervention area will have interview for two groups separately: Group X (intervention arm) and Group Y (Control arm). The alphanumeric ID analyzer uses UID of the participant and with a complex algorithm allocates him/her to either Group X or Group Y.

#### Intervention Area







Group Y: Receives advices for quitting smoking and ill effects of smoking. A follow up team from the centre will call the participant on daily basis and explain the ill effects of smoking and tobacco abuse.

Group X: Receives QuitSure app and not the doctor's advice separately. The investigator at the centre helps the participant to download the app on Android or IoS phone.

The registration of the participant will be based on UID.

## Intervention period: 6-10 days



A participant will be given 6-10 days time to go through the app (Group X) or Doctor's advice (Group Y).



During the app usage a participant can directly call the team of researchers/investigators. However, there will be no additional intervention given to IG.




The CG will receive doctor's assistance by telephonic counseling.

# Self reporting of quitting

- The participants will be given 6-10 days time to use the app, in between 6 and 10<sup>th</sup> day anytime the participant can call the team and self report.
- In case the participant does not selfreport researcher team will call the participant and ask about the status.
- ► IG and CG will call their own participants and document if there is any incident of quitting.
- ► The day of quitting is documented as D=0
