Release, Waiver of Liability, and Hold Harmless Agreement

This Release and Hold Harmless Agreement (“Agreement”) is entered into by the Client (“Client”) as a condition of participation in and use of Qtorpia Picnic Experience services, equipment, décor, and event furnishings.

By booking services, the Client voluntarily agrees to the terms stated below.

1. Assumption of Risk

The Client understands and acknowledges that picnic layouts, low-level seating arrangements, floor cushions, blankets, low tables, decorative props, outdoor ground surfaces, and ambient décor elements may involve inherent physical and environmental risks, including but not limited to:

- slips, trips, or falls
- uneven ground or terrain
- seated floor-level movement
- weather exposure
- insect presence
- general guest movement around décor and equipment

The Client agrees that participation in the picnic experience is voluntary for all guests and attendees.

2. Supervision & Guest Responsibility

The Client acknowledges that Qtorpia Picnic Experience does not provide:

- childcare
- attendee supervision
- guest behavior management
- crowd control services

The Client remains solely responsible for:

- supervising minors and guests
- ensuring appropriate and safe participation
- preventing rough play, climbing, or misuse of décor
- monitoring environmental and weather conditions

3. Release & Hold Harmless

To the fullest extent permitted by law, the Client hereby releases, waives, and agrees to hold harmless Qtorpia Picnic Experience, its owners, employees, assistants, and contractors from any and all claims, actions, demands, or liabilities arising out of or related to:

- slips, trips, or falls involving blankets, cushions, décor, or floor seating
- minor injuries occurring during normal event participation
- outdoor environment conditions including heat, wind, insects, or uneven terrain
- allergic reactions or sensitivities to materials
- incidents resulting from lack of supervision or guest behavior
- improper or unsafe use of equipment or décor

This release does not apply to claims arising from gross negligence or intentional misconduct by Qtorpia Picnic Experience.

- guest-caused or negligence-based damages
