

Declaration of Embodied Authorship & Rights of Enforcement Codex



Copyright & Trademark Assignment

Preamble

I, _______, the Living Author, resident and now 'National of Area 52 – Ex Terra, Global Commons', assert that my physical image, likeness, and embodied form — including face, body, voice, signature, and all biometric markers (biomarkers)— are authored works. They originate from no source other than me. They are not the property of any State, Corporation, or Third Party, and cannot lawfully or rationally be appropriated, harvested, or coerced without my explicit licence or that of my appointed Trustee (sic Area 52 – Ex Terra).

Article I — Authorship Defined

- **DNA** as Script: My DNA is the originating script, encoded as a living manuscript.
- Body as Authored Text: My physical form is the embodied fixation of that script.
- Conscious Alteration as Artistic Act: Any tattoo, surgery, adornment, or self-chosen modification is deliberate authorship an act of artistic expression equivalent in principle to sculpting or painting.
- Sole Authorship: No other "artist" may be identified as creator of my face, form, or expression; thus, authorship vests in me alone and hence all Trademark & Copyright extensions apply to me and through me and are recognised under International and Commercial Law

Article II — Copyright Assertion

- The Embodied Work constitutes an original authored work within the meaning and spirit of the Copyright, Designs and Patents Act 1988. (UK) and associated copyright legislation worldwide in relevant jurisdictions as well as within the Global Commons of Area 52 Ex Terra
- I assert **exclusive rights** of reproduction, adaptation, communication, distribution, and transformation over the Embodied Work and all derivatives (photographs, scans, digital captures, 3D models, biometric templates, AI embeddings).
- Any unauthorised act is **copyright infringement** actionable in civil law.
- I assert **moral rights** (attribution and integrity). Distortion, derogatory treatment, or misrepresentation of the Embodied Work is prohibited and actionable.

Article III — Trademark & Passing-Off Protections

- The Embodied Work functions as a **personal mark of origin** and identifier.
- Unauthorised commercial use, branding, advertising, or association constitutes **passing off** and, by analogy, trademark dilution.
- Remedies include injunctions, delivery-up, destruction of infringing materials, account of profits, and reputational disclosure.

Article IV — **Database Rights & Unfair Competition**

- Aggregating my biometric data into registries or ID databases without licence constitutes unlawful appropriation and database right infringement.
- Such conduct also amounts to **unfair competition** and unjust enrichment, for which I reserve civil and equitable remedies.

Article V — Data Protection & Privacy Rights

- Under UK GDPR and the Data Protection Act 2018, facial recognition and biometric data are "special category data."
- I explicitly **withhold consent** for capture, storage, or processing, save under written licence.
- Any unlawful processing will trigger regulatory complaint (ICO), civil claim, and injunctive relief.

Article VI — The Contradiction Clause

- UK law recognises identity categories (sex, gender, nationality) as mutable by declaration.
- Simultaneously, the State demands biometric identifiers as immutable and absolute.
- This is a fatal contradiction: identity cannot be both fluid and fixed.
- Any compulsory ID regime built on such incoherence is void, discriminatory, and vulnerable to judicial review.

Article VII — Trustee & Licence Control

- I reserve the right to appoint a Trustee (including independent jurisdictions such as Area52) to hold, register, and enforce these rights.
- No authority or agent may process my image or biometrics without express licence issued by myself or my Trustee.

Article VIII — Enforcement & Remedies

Infringement of this Declaration entitles me to pursue:

- Injunctions (interim and permanent).
- Statutory damages and compensatory damages under IP law.
- Account of profits and equitable relief.
- **Delivery-up or destruction** of infringing materials.
- ICO enforcement (fines, sanctions).

- Judicial review of state mandates violating these rights.
- **Public disclosure** of infringing acts for reputational and political remedy.

Article IX — Cease & Desist Demand

Recipients are hereby ordered to:

- 1. Cease all unauthorised processing of the Embodied Work.
- 2. **Preserve evidence** of any existing processing.
- 3. **Disclose** lawful basis, contracts, DPIAs, and retention policies within 14 days.

Failure to comply constitutes wilful infringement.

Closing Affirmation

My image and likeness are no longer "public data." They are now authored works, subject to copyright, trademark, moral rights, and sovereign authorship, and full karmic revocation of previous 'uninformed consent' has now been applied.

Any directive or mandate demanding surrender of my Embodied Work without licence and my express consent in writing, is null and void.
