6. Apart from paid booth space, vendors are not guaranteed additional supplies or reservations. Tables, chairs, office supplies or any other items are never guaranteed and there may be an additional charge for extra items.
  7. Vendors shall not pack up, cover their booths or load out before the designated times to do so and/or while the general public is still occupying the space during normal operating business hours.
  8. Vendors will maintain a booth open for business during the scheduled business hours. Booths are expected to be uncovered, manned, presentable and ready to sell as well as scheduling/maintaining a constant presence with someone authorized to sell their merchandise available at their booth during the hours open to the public.
  9. Vendors agree to stay within their designated booth space unless otherwise authorized to move or expand by Antique Show personnel as long as this move or expansion does not conflict with another vendor's space or all affected vendors agree to the change.
  10. Vendors agree to represent and price items in a fair and truthful manner. Materials, construction methods, item backstories, etc. shall not be fabricated or exaggerated in an effort to justify a price increase or mislead the customer. Vendors shall provide only the truthful, factual information they know to be true about their items at all times.
