Use of the Ono North Recreation Center (ONRC) for Fee-Based Activities

Guidelines, Rules, Regulations, Procedures

August 12, 2024

All activities, including but not limited to, lessons, coaching, training, leagues, tournaments, competitions, or social gatherings when a fee is charged for participation shall be governed by the Board of Directors at its sole discretion.

Such activities could include, among others:

Application Process: Each person or group that wishes to charge a fee or collect renumeration of any type must complete and submit the application form to the Board of Directors ten (10) or more days before the activity is planned to begin. The Board will review the application, get clarifications (as needed), and (1) approve, (2) disapprove, or (3) approve with modifications the application as quickly as possible. As soon as the Board has approved the application, the activities may begin. There is no need to wait after receiving written approval.

Who May Offer Activities for a Fee? Only members in good standing (including social members) of the Ono North Recreation Center (ONRC) may offer any activity for a fee.

Who May Participate in Fee-Based Activities Offered at the ONRC?

- (a) Members in good standing (including Social Members) of the ONRC may participate in all fee-based offerings.
- (b) Guests who neither reside nor own property on Ono Island must be guests of an ONRC member to participate in all fee-based offerings, and will be charged a facilities fee of five dollars (\$5.00) per visit, paid in advance. Guests attending a fee-based activity are to use only those facilities associated with the activity for a period not to exceed four (4) hours total upon each visit.
- (c) Ono Island residents and property owners may participate in all fee-based offerings and must be a guest of a ONRC member, and are to use only those facilities associated with the activity for a period not to exceed four (4) hours total upon each visit. Ono Island residents are encouraged to become Social Members of the ONRC so that they may take advantage of all the amenities, including fee-based activities. To encourage membership, and to give our Ono Island neighbors an opportunity to check out our facilities, the ONRC now offers a one-time **Trial Social Membership**. For a reduced fee of one hundred dollars (\$100.00), a resident family will receive an access card good for five (5) visits. The card expires at 11:59 pm on December 31 of the year issued. Trial memberships are not pro-rated and not renewable. If the family wishes to join as social members during the trial membership, the \$100.00 trial fee will be applied as credit to the initial Social Membership fee. Please have driver license with Ono address (or other proof of Ono Island ownership) when purchasing a Trial Social Membership.

Procedures, Rules, Regulations

Waiver of Liability: All participants in any fee-based activity must have a completed and signed Waiver of Liability form on file with the ONRC office BEFORE participating in any activity.

Office Hours: Office hours are 8:00 AM – 3:30 PM CT. Please make all submissions between those hours.

Sign in: The Activity Leader (the person whose name appears on the application) will ensure that an accurate roster of each participant is submitted to the ONRC office immediately after the activities of the day. This roster will fulfill the sign-in requirement.

Guest Fees: Guest fees will be collected by the activity leader BEFORE the activity begins. The activity leader will turn in **to the facility attendant** (1) all fees and (2) a typed and printed roster of attendees with each person marked as Member, Social Member, or Guest.

Time Limits: Each fee-based session will last no longer than ninety (90) minutes. At that time, if a member wished to use the area, and no like amenity is available, the fee-based activity must yield the space to the member. (i.e., if all other tennis courts, pickle ball courts, etc. are in use).

***Special note for tennis lessons: No more than 2 tennis courts may be occupied at one time by the activity leader's groups. When a second court becomes necessary, it must be adjacent to the first court (i.e., inside the same fenced area). At no time will tennis lessons be conducted on the court next to the Pickle Ball courts.

Fee-Based sessions will start no earlier than 7:00 AM CT and end no later than 10:00 PM CT.

Storage Fee: The Board of Directors reserves the right, in its sole discretion, to charge the conductor of the activity a fee for storing equipment at the ONRC.

Failure to Comply: Each guideline, rule, regulation, and procedure in these documents must be adhered to *completely and consistently*. Failure to comply will result in the Activity Leader losing the privilege to conduct, partner with, or profit from any fee-based activities at the ONRC.
