

BOIL WATER NOTICE

Cochiti Community Development Corporation

Town of Cochiti Lake

Date: November 2025



This notice is to inform all residents of the Town of Cochiti Lake that the Boil Water Advisory will remain in effect until further notice.

Due to current Well 1 upgrades and maintenance, mandatory water sampling has been completed and submitted to the laboratory for testing. We are currently awaiting clean results before the boil notice can be lifted. These tests are required any time a well undergoes repairs or maintenance to ensure the safety and quality of the water supply after system work is performed.

Until we receive final confirmation of water safety, all residents must continue to boil water before consumption, including for drinking, cooking, washing produce, brushing teeth, and preparing infant formula.

Water pressure should be fully restored as the system completes the current maintenance.

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER
Failure to Correct Significant Deficiencies

The **Cochiti Lake Public Water System (PWS ID 063568423)** failed to correct one significant deficiency identified during a sanitary survey within the timeline required by the Safe Drinking Water Act. This has resulted in a violation of the Ground Water Rule. Even though this was not an emergency, as our customers, you have a right to know what happened and what we are doing to correct this situation.

What happened?

On March 26, 2024, EPA performed a detailed evaluation of our water system, called a Sanitary Survey, and from this survey, the EPA identified 8 significant deficiencies. One of these significant deficiencies remained unaddressed past the established deadline of October 7, 2024.

What should I do?

- There is nothing you need to do at this time. You do not need to boil your water or take other actions.
- You may continue to drink the water. If a situation arises where the water is no longer safe to drink, you will be notified within 24 hours.

What does this mean?

This is not an emergency. If it had been, you would have been notified within 24 hours. But as our customer, you have a right to know what happened and what we are doing to correct this situation. *Inadequately treated or inadequately protected water may contain disease-causing organisms. These organisms can cause symptoms such as diarrhea, nausea, cramps, and associated headaches.* However, these symptoms are not only caused by organisms in drinking water, but also by other factors. If you experience any of these symptoms and they persist, you may want to seek medical advice.

What is being done?

CCDC is currently in the process of upgrading well components due to recent failures. During this upgrade the blow off valve needed to be in compliance will be addressed.



IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER
No Licensed Operator for Cochiti Lake Public Water System (PWS ID 063568423)

The **Cochiti Lake Public Water System (PWS ID 063568423)** has incurred a violation of the National Primary Drinking Water Regulations under the Stage 1 Disinfectants and Disinfection Byproducts Rule, specifically, for failure to retain a qualified, licensed drinking water operator to operate the drinking water system. Even though this was not an emergency, as our customers, you have a right to know what happened and what we are doing to correct this situation.

The U.S. Environmental Protection Agency defines a qualified licensed operator as a person holding an appropriate valid Water Operator's License based on the type of water system and population served.

What happened?

CCDC does not currently have a licensed water operator. CCDC has been collaborating with the Cochiti pueblo maintenance department for water quality tests. Cochiti pueblo maintenance department has two certified water operators and will assist CCDC until the current Utility operators have passed certification tests. Currently two CCDC employees are undergoing correct process to acquire level 1 certifications.

What should I do?

There is nothing you need to do at this time.
