After graduation, she clerked for the Honorable Michael W. Farrell of the District of Columbia Court of Appeals. She received her B.A. from Newcomb College of Tulane University. She also serves in Board and leadership capacities with both state-based and national civil justice reform organizations around the country.

Nathan Morris serves as the senior director of legislative affairs at the U.S. Chamber Institute for Legal Reform. He is responsible for legal reform advocacy efforts in Washington, D.C. and in state capitols throughout the country. Before joining ILR, Nathan served as Legal Assistant to the General Counsel of the United States Sentencing Commission and as Professional Staff to the U.S. Senate Committee on the Judiciary, where he advised legislators on antitrust, asbestos, bankruptcy, class action, data privacy, intellectual property, and other civil law and litigation issues. University. He holds a J.D. from American University's Washington College of Law and is admitted to practice law in Washington, D.C.

Shana O'Toole is the Founder and President of the Due Process Institute - a nonprofit, bipartisan, public interest organization that works to honor, preserve, and restore procedural fairness in the criminal justice system. Prior to founding the Due Process Institute, Shana-Tara O'Toole served as the White Collar Crime Policy Director for the National Association of Criminal Defense Lawyers (NACDL). In that capacity, she led NACDL's strategic partnership with other organizations on multiple federal legislative initiatives designed to prevent the further erosion of civil liberties in our criminal justice system. Prior to joining NACDL, Shana practiced as a defense lawyer representing clients in civil and criminal investigations. She also served as *pro bono* immigration counsel for political refugees seeking asylum. Before she found her calling as a legal reformer, Shana received a Master of Fine Arts in fiction writing from the University of New Orleans. While there, she taught literature and writing at several Louisiana colleges.

William Shepherd is a trial lawyer in Holland & Knight's West Palm Beach and Washington, D.C., offices. Bill represents clients involved in civil and criminal government investigations. Yates* and the conviction of commercial fisherman John Yates under Sarbanes-Oxley for the "destruction" of three red grouper.
